Summary of Decisions

1. **Corey Omar Bonilla** (Report No. 7241)
Applicant for a Tow Truck Driver's Licence (Application No. B922240)

DECISION:

The Tribunal approved the withdrawal of Report No. 7241 at the request of Municipal Licensing and Standards.

Application B922240 was cancelled at the request of the applicant.

(Mr. Bonilla did not attend today's hearing)

2. **Sangeef Sasikumar** (Report No. 7256)
Applicant for a Tow Truck Driver's Licence (Application No. B924461)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on August 20, 2019.

Tow Truck Driver's Licence will be issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Mr. Sasikumar must submit to Municipal Licensing and Standards, proof of completion of an anger management course, totalling ten (10) hours, as part of his conditional discharge from criminal court;
- (3) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of three (3) years. Mr. Sasikumar is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Sasikumar and conduct other investigations, as appropriate, to assess Mr. Sasikumar's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;

- (4) Prior to each of the next three (3) renewals of the licence, Mr. Sasikumar must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Sasikumar or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7256 and any updating material, may be brought back before the Tribunal for a full hearing.

3. Fazlin Abdul Karim (Report No. 7206)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4075030

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on August 20, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Abdul Karim is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Abdul Karim and conduct other investigations, as appropriate, to assess Mr. Abdul Karim's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Abdul Karim or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7206 and any updating material, may be brought back before the Tribunal for a full hearing.

Applicant for a Public Garage Licence (Application No. B909639)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on August 20, 2019.

Public Garage Licence will be issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Public Garage Licence will be placed on probation for a period of three (3) years. Mr. Sayed and Mr. Dawud are advised that during the probationary period, MLS may make additional checks of any criminal and by-law charges and convictions against Flex Auto Care & Detailing Inc., Mr. Sayed and Mr. Dawud and conduct other investigations, as appropriate, to assess Flex Auto Care & Detailing Inc., Mr. Sayed and Mr. Dawud's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Sayed must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Flex Auto Care & Detailing Inc., Mr. Sayed and/or Mr. Dawud or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7252 and any updating material, may be brought back before the Tribunal for a full hearing.

5. Bassam Abdallah (Report No. 7226)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4544133

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on August 20, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Vehicle-For-Hire Driver's Licence will be renewed and immediately suspended for one (1) day. Mr. Abdallah must surrender his licence and photo card to Municipal Licensing and Standards on the first day of the suspension;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Mr. Abdallah is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Abdallah and conduct other investigations, as appropriate, to assess Mr. Abdallah's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Abdallah or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7226 and any updating material, may be brought back before the Tribunal for a full hearing.
