## **Clothing Drop Box Operator**

For-Profit and Not-For-Profit Organizations are required to obtain a Clothing Drop Box Operator Licence.(B90)

#### How can I apply?

#### What documents and information do I need to provide if applying in person?

- **D** Business Registration Master Business Licence
- **Clothing Drop Box Removal Declaration (Form provided)**
- Articles of Incorporation;
- □ Two Pieces of Government Issued Photo Identification for every Officer/ Director on file;
- **Criminal Record and Judicial Matters Check for every Officer/Director on file;**
- List of Clothing Drop Box Locations;
- **Annual Return for Limited Companies (Form provided)**
- **Application and Licence Fee**
- **Charity Declaration Form if applicable (Form provided) & Confirmation from CRA of Charitable Status**

#### Please note:

- All clothing drop box operators require a location permit for each box.
- Only two drop box will be allowed per municipal address.
- All clothing drop box operators, INCLUDING charitable organizations, must display the permit sticker sticker colors will denote the type of box

# NOTICE REGARDING CRIMINAL BACKGROUND CHECKS

Effective November 1, 2018, the new **Criminal Record and Judicial Matters Background Check** is mandatory when making a new application and/or renewal for a Business Licence in the City of Toronto.

The new check must be updated every four years and is required prior to a licence being issued.

#### Please note:

- Originals are required (copies <u>will not</u> be accepted).
- Checks completed by a third party agency <u>will not</u> be accepted. You must obtain directly through a Canadian Police Service.
- Checks with an issue date greater than 280 days will not be accepted.

A Criminal Record and Judicial Matters Background Check can be obtained from a <u>Canadian Police Service</u> at one the following locations to complete your application or renewal.
