Laird in Focus

Launched in November 2016, the purpose of the Laird in Focus Study was to focus and shape anticipated growth around the intersection of Eglinton Avenue East and Laird Drive and along the west side of Laird Drive, anchored by the transit infrastructure being constructed as part of the Eglinton Crosstown Light Rail Transit (LRT).

In July 2018, City Council adopted a Proposals Report for Laird in Focus and directed staff to undertake additional consultation and bring forward a draft Site and Area Specific Policy.

The draft Site and Area Specific Policy provides for a planning and infrastructure framework to accommodate future population and job growth around the Eglinton Crosstown LRT station, address transportation and servicing capacity issues and create a plan for a complete, mixed use and vibrant community. It reflects the outcomes of multiple phases of work and input provided by residents and stakeholders through a number of community meetings, open houses and pop-up events.

Planning Application Proposal for: 815-845 Eglinton Avenue East - RioCan Leaside Centre

The proposal is for a mixed-use development comprised of residential and commercial uses in buildings ranging in height from 10 and 12-storeys on Laird Drive, 9 and 10-storeys on Eglinton Avenue East, and central to the site are 18, 21, 36 and 38-storey buildings with 1,673 residential units, a 4-storey office building, a total gross floor area of 136,730 m², and a floor space index of 3.84. Also proposed is a 1-storey building with 2,100m² of community space, 3,770 m² public park, private road internal to the site, a new north-south Don Avon Drive public road extension and 1,106 vehicular parking spaces on two levels underground.
