## Road Resurfacing on Carlisle Crescent, Littleborough Court, Orleans Drive, Rylander Boulevard and Tideswell Boulevard

**Expected Start Date: Spring 2019**

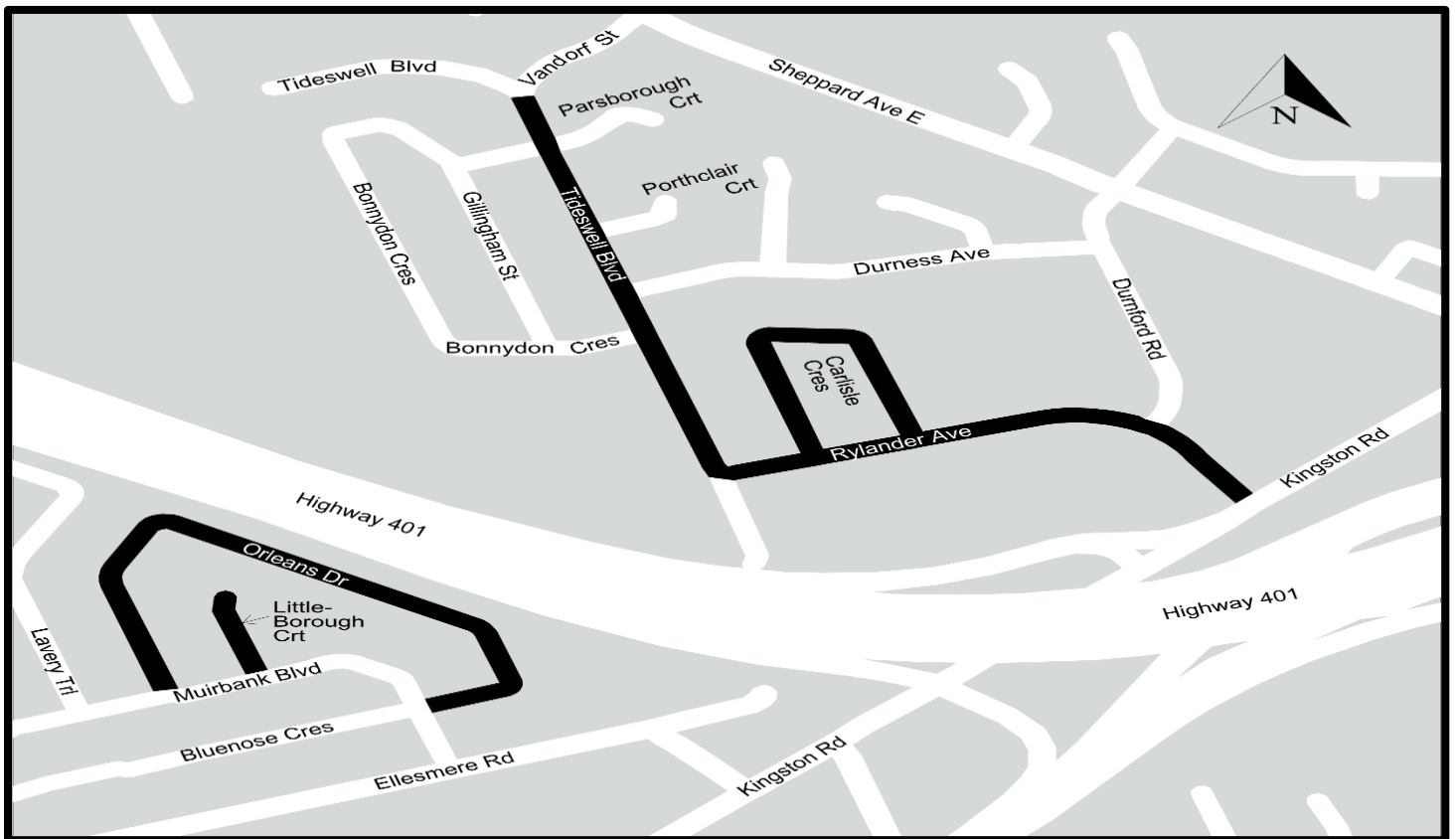
**Expected End Date: Fall 2019**

The City of Toronto is planning to replace damaged curbs and sidewalks and resurface Carlisle Crescent, Littleborough Court, Orleans Drive, Rylander Boulevard and Tideswell Boulevard (see map). Our inspection of the road shows that it needs repaving and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair.

This work is part of the Council-approved 2019 Capital Works Program to renew aging city roads and sidewalk for current and future needs.

## WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark sidewalks and curbs requiring replacement and the locations of underground utilities, such as gas, water, and electrical cables so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.
- Work in the boulevard in front of homes and commercial properties is expected. This work includes removing and replacing driveways, municipal sidewalks and grassed boulevards, where necessary.

	<p><b>Accessible Accommodation:</b> Residents who require accommodation (level entry, longer notice, etc.) must contact the <b>Field Ambassador</b> to arrange for access during the construction period.</p>
	<p><b>Important information for owners of sprinkler systems / heated driveways and private landscaping features.</b> Property owners should remove items located within City property limits (boulevard) to avoid damage.</p> <p>This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the <b>Field Ambassador</b> listed below.</p>
