City Council confirmatory By-law No. 1448-2012 enacted on November 1, 2012 Prepared By: Trixy Pugh Division: **Real Estate Services** Date Prepared: Phone No.: September 18, 2019 (416) 392-8160 Deputy City Manager, Corporate Services ("DCM, CS") has approval authority to approve the disposal to Metrolinx of certain Transit Lands for nominal consideration, (on terms satisfactory to the DCM, CS and in a form acceptable to the City Solicitor). To obtain authority to enter into a temporary licence with Metrolinx over part of 449 Sentinel Road, as required for the Purpose implementation of the Finch West Light Rail Transit Project (the "Project"). Part of the Fountainhead Park, located at 449 Sentinel Road, described as Parcel J-1, Section M1299, Block J on Plan Property M1299, Township of York/North York, shown as Part 4 on the attached draft R-Plan 2016-04172-7(002) (the "Property") in Appendix "A". Authority to grant a temporary licence (the "Licence") to Metrolinx, for a term of five (5) years, commencing November Actions 7, 2019, and expiring upon the earlier of November 6, 2024 or the closing of the acquisition by Metrolinx of a permanent easement in the Property, in connection with the construction of the Project, on terms and conditions as set out herein and as deemed appropriate by the DCM, CS or his/her designate, and in a form satisfactory to the City Solicitor. There is no financial impact resulting from this approval. **Financial Impact** Pursuant to Schedule "F" (Real Estate Protocol) contained in the Master Agreement between the City, the Toronto Transit Commission and Metrolinx for the implementation of the Toronto Light Rail Transit Program dated November 28, 2012 ("Master Agreement"), temporary use property requirements not required for City purposes are transferred to Metrolinx for nominal consideration. The Chief Financial Officer and Treasurer has reviewed this DAF and agrees with the financial impact information. Metrolinx has requested for a permanent easement over the Property for the relocation of a Toronto Hydro guy wire. Comments The Property forms part of Fountainhead Park and has the Official Plan designation of Parks and Open Space Areas. Metrolinx requires an Official Plan Amendment (the "OPA") in order to proceed with a permanent easement and the City has agreed to the five (5) year licence in order to provide Metrolinx time to apply for the OPA.
