## Intersection Improvements at Kennedy Park Road and Margdon Road

Contract: 19ECS-TI-12LR Start Date: November 11, 2019 End Date: December 13, 2019 \*Timeline is subject to change.

The City of Toronto will improve the intersection at Kennedy Park Road and Margdon Road. This work will involve realigning curbs and sidewalks at this intersection for increased safety. Intersection safety improvements provide a number of benefits:

- Improved sight lines for motorists and pedestrians
- Reduced vehicle speeds due to radii reductions
- Improved accessibility and user experience for all pedestrians due to shortened crossing distance at Margdon Road cross walk.

This project is part of the Council-approved 2019 Capital Works Program.

#### WORK DETAILS

The City's contractor will:

- Construct sidewalk and curb on the southeast and southwest sides of Kennedy Park Road and Margdon Road
- Reduce corner radii
- Install tactile walking surface indicators
- Replace catchbasins
- Restore the affected area

### WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- Property owners should remove items located within City property limits (boulevard), such as landscaping and / or decorative objects. If you have a sprinkler system within the boulevard, please contact the Project Manager.
- The City will not be responsible for damage to any privately owned items on City property.

|   | <b>Work Hours</b> : Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.   |

|   | <b>Pre-Construction Inspection:</b> GPM Environmental, under contract to the City of Toronto, will survey all properties within 30 metres of the construction area before construction starts. Participation in the survey is voluntary; however, participating is important in determining if the construction caused damage. The inspection will look at both the interior and exterior of all properties to verify existing conditions. The company will deliver a separate notice requesting time to set up appointments. All inspection staff will be wearing photo identification and carrying photographic equipment during their work.   |
| ÷ | <b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.  |
|   | <b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.   |
| 8 | <b>Traffic Management</b> : Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Some of these efforts include adding Local Access signs, revising traffic signal times. Road users should expect delays and increased traffic on nearby main and side streets.   |
