Road Resurfacing on Austin Terrace from Walmer Road to Spadina Road



The City of Toronto will resurface the road on Austin Terrace from Walmer Road to Spadina Road. The contractor will also repair damaged curb and sidewalk where required.

Our inspection of the road shows that it needs repaying and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair. This work is part of the Council-approved 2019 Capital Works Program to renew aging city roads and sidewalk for current and future needs.

WORK DETAILS

In November, the City's contractor will:

Repair curb, gutters and driveways

In May 2020, the City's contractor will return to:

- Dig up the road surface
- Repair the concrete road base
- Re-adjust maintenance holes and catch basins
- Repave the road surface

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.

Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.

| | Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October). |
