TORONTO LICENSING TRIBUNAL: October 10, 2019 Summary of Decisions E. Montigny / A. Bakshi / V. Francis

1. 2418313 Ontario Inc. [Vendor] (Report No. 7239)

DECISION:

The Tribunal approved the joint Proposed Resolution signed on October 10, 2019.

Body Rub Parlour Owner/Operator's Licence will be issued to 2663781 Ontario Corp., subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled:
- (2) Immediately upon being issued, Body Rub Parlour Owner/Operator's Licence will be placed on probation for a period of <u>One</u> (1) year. Eric Jing On Tsui is advised that during the probationary period, MLS may make additional checks of any criminal and by-law charges and convictions against 2663781 Ontario Corp. and Eric Jing On Tsui and conduct other investigations, as appropriate, to assess 2663781 Ontario Corp. and Eric Jing On Tsui's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) 2663781 Ontario Corp. and Eric Jing On Tsui are not to employ as manager any previous manager from Amore Spa at Seduction@Airport, as listed in the attached Schedule 'A'. (filed on October 10, 2019).

(4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against 2663781 Ontario Corp. or Eric Jing On Tsui or any other concerns with respect to the conduct of the licensee, those matters and report no. 7239 and any updating material, may be brought back before the Tribunal for a full hearing.

2. Cemil Caliskan (Report No. 7152)

Holder of Vehicle-For-Hire Driver's Licence No. D01-4874770

DECISION:

The Tribunal approved the request for adjournment to October 17, 2019, on consent. MLS requested an adjournment to permit Mr. Caliskan additional time to decide whether or not he wishes to continue to hold his Vehicle-For-Hire Driver's Licence. Mr. Caliskan is required to attend on October 17, 2019 and provide his decision.

3. Guohua Xie (Report No. 7325)

Holder of Holistic Practitioner Licence No. T30-4671106

DECISION:

The Tribunal approved the joint Proposed Resolution signed on October 10, 2019.

Mr. Xie's Holistic Practitioner Licence No. T30-4671106 (the "Licence") will be placed on an interim suspension, effective October 10, 2019, pending the final disposition of the Criminal Charge.

- (1) Mr. Xie understands that this Proposed Resolution has been reached on the basis of the information known as of today's date and as set out in Report No. 7325. At any time prior to the full hearing on the merits of this matter, if MLS has any new concerns with respect to the Licence and/or conduct of Mr. Xie, MLS may bring this matter back before the Tribunal for a further interim order.
- (2) It is the responsibility of Mr. Xie to advise MLS in writing as to the final disposition of the Criminal Charge, within five days of the disposition.
