
New Sidewalk Construction on Caledonia Road North of Castlefield Avenue

Contract #: 18ECS-TI-103LR Expected Start Date: May 13, 2019 Expected End Date: June 30, 2019 *Timeline is subject to change.

The City of Toronto will construct 95 metres of new sidewalk on the west side of Caledonia Road from 110m North of Castlefield Avenue to 205m North of Castlefield Avenue to complete the missing sidewalk link. The work also involves replacing the existing fire hydrant with a new fire hydrant.

This work is part of the Council-approved 2018 Capital Works Program to provide sidewalks for current and future needs.

WORK DETAILS

The City's contractor will:

- Mobilize preparing for sidewalk construction
- Replace Fire Hydrant
- Construct a new sidewalk on west side
- Restore areas affected by construction

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately-owned items on City property.



Accessible Accommodation: Residents who require accommodation (level entry, longer notice, etc.) must contact the **Field Ambassador** to arrange for access during the construction period.



Work Hours: Work will take place from 7:00 a.m. to 7:00 p.m., Monday to Friday, with work after hours and on weekends as required.



Pre-Construction Inspection: Wristen's Home Specialties Inc. (WHS) under contract to the City of Toronto, will survey all properties within 30 metres of the construction area before construction starts. Participation in the survey is voluntary; however, participating is important in determining if the construction caused damage. The inspection will look at both the interior and exterior of all properties to verify existing conditions. The company will deliver a separate notice requesting time to set up appointments. All inspection staff will be wearing photo identification and carrying photographic equipment during their work.



Important information for owners of sprinkler systems / heated driveways and private landscaping features. Property owners should remove items located within City property limits (boulevard) to avoid damage.

This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the **Field Ambassador** listed below.

The City will not be responsible for damage to any privately-owned items on City property.

Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets.

Traffic on Caledonia Road will be reduced to one lane in each direction within the work zone and to one lane with flag-persons, as required.



Parking: Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at **416-808-2222**.

In the event you receive a traffic ticket for on-street parking during this period of construction, you may choose to dispute your ticket following the process listed on the reverse side of the parking infraction notice. You may use this notice as part of your defence for parking consideration during construction; however, the Field Ambassador does not have the authority to cancel any parking tickets.



TTC Service: This project may affect travel times on the 47 BC Landsdowne bus. Visit ttc.ca for accurate schedule information.



Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Sod installation may be belayed to late summer for more ideal growing weather.
