## TORONTO LICENSING TRIBUNAL: October 3, 2019

### Summary of Decisions

- 1. Mehmood Abbas** (Report No. 7211)  
Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B903726)

#### DECISION:

The Tribunal dismissed Mr. Abbas' application for a Vehicle-For-Hire Driver's Licence and deemed the matter abandoned.

(Mr. Abbas failed to attend today's hearing)

- 2. Ramin Jourj** (Report No. 7272)  
Applicant for a Tow Truck Driver's Licence (Application No. B934873)

#### DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on September 6, 2019.

Tow Truck Driver's Licence will be issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of three (3) year(s). Mr. Jourj is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Jourj and conduct other investigations, as appropriate, to assess Mr. Jourj's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Jourj or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7272 and any updating material, may be brought back before the Tribunal for a full hearing.

**3. Denosan Subramaniam (Report No. 7193)**  
Holder of Tow Truck Driver's Licence No. D09-4650970

**DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on September 6, 2019.

Tow Truck Driver's Licence will be subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Tow Truck Driver's Licence will be immediately suspended for one (1) day(s). Mr. Subramaniam must surrender his photo card and licence to Municipal Licensing and Standards on Thursday, October 3, 2019;
- (3) Tow Truck Driver's Licence will be placed on probation for a period of three (3) year(s). Mr. Subramaniam is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Subramaniam and conduct other investigations, as appropriate, to assess Mr. Subramaniam's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Subramaniam or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7193 and any updating material, may be brought back before the Tribunal for a full hearing.

**4. Harish Karunairajah (Report No. 7230)**  
Applicant for a Tow Truck Driver's Licence (Application No. B913874)

**DECISION:**

The Tribunal approved the joint Proposed Resolution signed on October 3, 2019.

Tow Truck Driver's Licence will be issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;

- (2) Immediately upon being issued, Tow Truck Driver's Licence will be suspended for a period of four (4) day(s);
- (3) Upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of four (4) year(s). Mr. Karunairajah is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Karunairajah and conduct other investigations, as appropriate, to assess Mr. Karunairajah's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (4) Prior to each of the next four (4) renewal(s) of the licence, Mr. Karunairajah must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Karunairajah or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7230 and any updating material, may be brought back before the Tribunal for a full hearing.

**5. Denny Fernandes Duarte** (Report No. 7204)  
Holder of Tow Truck Driver's Licence No. D09-4854647

**DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on September 18, 2019.

Tow Truck Driver's Licence will be subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Tow Truck Driver's Licence will be placed on probation for a period of one (1) year(s). Mr. Duarte is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Duarte and conduct other investigations, as appropriate, to assess Mr. Duarte's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Duarte or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7204 and any updating material, may be brought back before the Tribunal for a full hearing.
