Dear Mr. Murray:

I would like to offer you congratulations upon the commencement of your new responsibilities as City Manager for the City of Toronto.

OLG is committed to working with the City and we look forward to continuing our long and productive relationship.

I am writing to you regarding the meeting of the Toronto City Council on April 24 – 26, 2018, where Council confirmed its support of expanded gaming at 555 Rexdale Blvd by adopting the recommendations in item EX33.2.

I am pleased to respond to the additional recommendations to the staff report on which Council approved.

The first motion requested an invitation be extended to several organizations, in addition to those already identified in Terms of Reference, asking them to participate in the Casino Woodbine Responsible Gambling Oversight Committee.

The Terms of Reference considered by City Council stated the Oversight Committee would be chaired by OLG and that Ontario GTA Gaming LP (OGGLP) and the City of Toronto, including designates from Toronto Public Health, would be founding members. Other organizations, with applicable knowledge and experience, would then be invited to participate in the Committee.

The Terms of Reference initially identified the following organizations to participate in the Committee:

- Ministry of Health and Long-Term Care;
- Alcohol and Gaming Commission of Ontario (AGCO);
- The Centre for Addiction and Mental Health (CAMH);
- The Responsible Gambling Council;
- YMCA;
- William Osler Health System;
- Local addiction and treatment organizations; and
- Local community groups and credit counselling organizations

At the April 24-26, 2018 Council meeting, Council requested that Casino Woodbine management and community employment stakeholders, including Humber College, local employment service organizations, and labour representation on behalf of the Locals representing Woodbine site employees, be added to the list of organizations invited to participate on the Committee.


I am pleased to confirm that OLG has extended an invitation to the organizations outlined in the original Terms of Reference, as well as those added at the City's request.

At the Council meeting on April 22-26, 2018 Council also requested that the City Manager work with OLG and report back on a process to address remedies and possible penalties, for failure to comply with requirements of the Community Benefits Agreement, including failure to achieve agreed-to targets by the first quarter of 2019.

I am pleased to confirm that OLG will work with the City Manager on this undertaking for a report back by the first quarter for 2019.
