**TORONTO LICENSING TRIBUNAL: October 31, 2019**  
**Summary of Decisions**

- 1. Richard P. Mijares** (Report No. 7195)  
Holder of Vehicle-For-Hire Driver's Licence No. D01-4653527

**DECISION:**

The Tribunal approved the withdrawal of Report No. 7195 by Municipal Licensing and Standards.

Licence No. D01-4653527 expired on July 18, 2019. Municipal Licensing and Standards did not receive the renewal payment, therefore the licence was automatically cancelled on October 18, 2019.

Applicant for the Renewal of Driving School Instructor with Vehicle Licence  
No. V11-3842125, Plate No. 5034

**DECISION:**

The Tribunal approved the request for adjournment to February 27, 2020 on consent.

Mr. David Gourlay, City Legal, confirmed that he spoke to Mr. Kabir Sharma, Solicitor for the Licensee and advised him that Municipal Licensing and Standards is requesting an adjournment to conduct further investigations, in this matter. Mr. Sharma agreed to this request.

- 5. Kains Soisa Robert Kenedi Soisa** (Report No. 7302)  
Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4722506

**DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on October 1, 2019.

Tow Truck Driver's Licence will be renewed, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Tow Truck Driver's Licence will be placed on probation for a period of two (2) year(s). Mr. Robert Kenedi Soisa is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Robert Kenedi Soisa and conduct other investigations, as appropriate, to assess Mr. Robert Kenedi Soisa compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Robert Kenedi Soisa or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7302 and any updating material, may be brought back before the Tribunal for a full hearing.

**6. Abdul Majid Mehraban (Report No. 7304)**  
Applicant for a Tow Truck Driver's Licence (Application No. B944199)

**DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on October 1, 2019.

Tow Truck Driver's Licence will be issued to Mr. Mehraban, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow truck Driver's Licence will be placed on probation for a period of two (2) year(s). Mr. Mehraban is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Mehraban and conduct other investigations, as appropriate, to assess Mr. Mehraban's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next two (2) renewal(s) of the licence, Mr. Mehraban must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Mehraban or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7304 and any updating material, may be brought back before the Tribunal for a full hearing.

**7. Densilraj Donald Soisa (Report No. 7279)**  
Applicant for a Tow Truck Driver's Licence (Application No. B937937)

**DECISION:**

The Tribunal approved the joint Proposed Resolution.

Tow Truck Driver's Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;

- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of four (4) years. Mr. Donald Soisa is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Donald Soisa and conduct other investigations, as appropriate, to assess Mr. Donald Soisa's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next four (4) renewals of the licence, Mr. Donald Soisa must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Donald Soisa or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7279 and any updating material, may be brought back before the Tribunal for a full hearing.

**8. Miriza Khan (Report No. 7309)**

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B945402)

**DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on October 1, 2019.

Vehicle-For-Hire Driver's Licence will be issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) year(s). Mr. Khan is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Khan and conduct other investigations, as appropriate, to assess Mr. Khan compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewal(s) of the licence, Mr. Khan must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;

- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Khan or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7309 and any updating material, may be brought back before the Tribunal for a full hearing.
