



Ashbridges Bay Treatment Plant Integrated Pumping Station – Phase 2

Contract #: 18ECS-MI-01DC Start Date: October 2019 End Date: September 2022 *Timeline is subject to change.


The City of Toronto will be constructing a new Integrated Pumping Station (IPS) at the Ashbridges Bay Treatment Plant (ABTP). Since Phase 1 work was completed earlier this year, Phase 2 work will construct new trunk sewers to convey sewage and connect the new IPS to the ABTP for treatment. Upon completion of the new Integrated Pumping Station, the M&T Pumping Station buildings will be decommissioned as they will have reached their useful life expectancy, but will remain in place.

This project is part of the Council-approved 2018-2029 Capital Works Program.

WORK DETAILS

During construction at Ashbridges Bay Treatment Park (North Site):

- Relocation of the Martin Goodman Trail
- Fencing and hoarding will be erected around the work site
- Selected tree removals
- Excavation will take place to install the new sewers

During construction at the Ashbridges Bay Treatment Plant (South Site):

- Excavation of the concrete shafts for the new Integrated Pumping Station
- Underground tunneling across Lake Shore Boulevard to connect the new sewers to the Integrated Pumping Station
- Demolition of the water tower

WHAT TO EXPECT DURING CONSTRUCTION

You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. Your patience is appreciated.

	Work Hours : Work will take place from 7:00 a.m. to 7:00 p.m., Monday to Friday. Work on weekends as required and approved (Saturdays is 9:00 a.m. to 7:00 p.m.) with No Sundays.	
	Park Access: In order to complete the work in a safe manner, the west side of the park will be closed during construction. The Skateboard Park and Rugby Field will remain open.	
~	Ashbridges Bay Park (North Site) Access: Construction vehicles will access the site from Eastern Avenue, west of Coxwell Avenue only.	
8	Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. No significant delays are expected during construction.	
	This work will not impact traffic on Lake Shore Boulevard East.	
	Vehicular access to Ashbridges Bay parking lot will be maintained.	
+	Tree Removal: The City has worked to preserve as many trees as possible and trees will be preserved through tree protection measures; however, 72 City-owned trees within the construction area at Ashbridges Bay Park will be removed. New trees will be planted when construction is complete.	
	Restoration: Areas affected by construction will be restored as required.	
GTO	Cycling: The Martin Goodman Trail located near the North Site will be relocated before construction hoarding is installed to maintain access at all times.
