## TORONTO LICENSING TRIBUNAL: November 14, 2019

### Summary of Decisions

#### M. Laverty / E. Montigny / D. Simon

1. **Matthew Mark Martino** (Report No. 7225)  
Applicant for a Tow Truck Driver's Licence (Application No. B916587)

#### DECISION:

The Tribunal deemed Mr. Martino's application as abandoned. Mr. Martino is welcome to resubmit an application in the future.

(Mr. Martino failed to attend today's hearing)

2. **Hassan Khalid** (Report No. 7276)  
Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B935220)

#### DECISION:

The Tribunal ordered a Vehicle-For-Hire Driver's Licence be issued to Mr. Khalid, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Khalid is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Khalid and conduct other investigations, as appropriate, to assess Mr. Khalid's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Khalid or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7276 and any updating material, may be brought back before the Tribunal for a full hearing.

**3. Pirasanth Loganathan (Report No. 7313)**  
Applicant for a Tow Truck Driver's Licence (Application No. B929814)

**DECISION:**

The Tribunal adjourned this matter to November 28, 2019. The Tribunal further ordered the parties to meet prior to the above date and discuss the originally signed Proposed Resolution on October 22, 2019; to remain in place or discuss the potential of other terms of agreement.

The Proposed Resolution signed on October 22, 2019 was not approved by the Tribunal. Municipal Licensing and Standards raised concerns that they can no longer agree to the Proposed Resolution as it currently stands. MLS requested additional time to further investigate information contained in Report No. 7313 and additional charges that were laid following the Pre-hearing conference on October 22, 2019.

**4. Jimmy Jay John Robert Moore Lungley (Report No. 7306)**  
Applicant for a Tow Truck Driver's Licence (Application No. B942655)

**DECISION:**

The Tribunal adjourned this matter to November 21, 2019. The Tribunal further ordered the parties to meet prior to the above date and discuss the potential of the originally signed Proposed Resolution on October 22, 2019, to remain in place or to discuss other terms of agreement.

The Proposed Resolution signed on October 22, 2019 was not approved by the Tribunal, Municipal Licensing and Standards raised concerns that they can no longer agree to the Proposed Resolution as it currently stands. MLS requested additional time to further investigate information contained in report No. 7306 and additional charges that were laid following the Pre-hearing conference on October 22, 2019.

**5. Christopher Anthony Pacitto (Report No. 7335)**  
Applicant for a Tow Truck Driver's Licence (Application No. B948931)

**DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on October 22, 2019.

Tow Truck Driver's Licence will be issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;

- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of three (3) year(s). Mr. Pacitto is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Pacitto and conduct other investigations, as appropriate, to assess Mr. Pacitto's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Pacitto or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7335 and any updating material, may be brought back before the Tribunal for a full hearing.

**6. Mohamed Akil Bacchus** (Report No. 7213)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4692656

AND

Holder of Taxicab Owner's Licence No. V02-3129389

**DECISION:**

The Tribunal adjourned this matter sine die, pending the final disposition of criminal charges. The Tribunal ordered an interim suspension, effective immediately on Mr. Bacchus' Vehicle-For-Hire Driver's Licence until such time the Tribunal orders otherwise. Mr. Bacchus must surrender his photo card and licence to Municipal Licensing and Standards on Thursday November 14, 2019.

Mr. Bacchus' Taxicab Owner's Licence No. V02-3129389 continues to be valid.
