TORONTO LICENSING TRIBUNAL: December 5, 2019 Summary of Decisions D. Simon / A. Bakshi / M. Lee

1. Sarbjit Singh Sahota (Report No. 7212) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B910320)

DECISION:

The Toronto Licensing Tribunal reserved their decision for this matter at today's hearing.

The Tribunal will deliberate further and issue a Written Decision within the next 30 days.

2. Fazal-Ur-Rehman Khan (Report No. 7185) Holder of Vehicle-For-Hire Driver's Licence No. D01-4655666

DECISION:

The Tribunal approved the withdrawal of Report No. 7185 by Municipal Licensing and Standards.

Licence No. D01-4655666 expired on August 4, 2019. Municipal Licensing and Standards did not receive the renewal payment, and therefore the licence was cancelled on November 4, 2019.

(Mr. Khan failed to attend today's hearing.)

 Silva Groceries Ltd. (Report No. 7307) o/a Silva Groceries Jason Silva, Director Applicant for a Retail Store (Food) Licence (Application No. B938979)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on November 19, 2019.

Retail Store (Food) Licence will be issued, subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being issued, Retail Store (Food) Licence will be placed on probation for a period of one (1) year. Mr. Silva is advised that during the probationary period, MLS may make additional checks of any criminal and by-law charges and convictions against Silva Groceries Ltd. and Mr. Silva and conduct other investigations, as appropriate, to assess Silva Groceries Ltd. and Mr. Silva's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next one (1) renewal of the licence, Mr. Silva must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Silva Groceries Ltd. and/or Mr. Silva or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7307 and any updating material, may be brought back before the Tribunal for a full hearing.
- 4. Golam Mustafa (Report No. 7084) Holder of Vehicle-For-Hire Driver's Licence No. D01-3250234

DECISION:

The Tribunal issued the following interim order:

(1) All conditions imposed on Mr. Mustafa's Vehicle-For-Hire Driver's Licence on October 25, 2018 be removed until the Tribunal orders otherwise; December 5, 2019

- (2) Mr. Mustafa shall notify Municipal Licensing and Standards of any new criminal charges or convictions under the Criminal Code of Canada within three (3) business days. Mr. Mustafa can notify Municipal Licensing and Standards in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102

The notification shall include his MLS licence number and the ticket number(s).

This matter will be adjourned sine die pending the outcome of the final disposition of your criminal matters.
