TORONTO LICENSING TRIBUNAL: November 28, 2019 Summary of Decisions E. Montigny/ M. Carter-Whitney/ M. Laverty

1. Estate of Joseph Kay (Report No. 7369)

Fay Kay, Estate Trustee Holder of Taxicab Owner's Licence No. V02-4883898, Taxicab Plate No. 1364

DECISION:

The Tribunal approved an extension of Taxicab Owner's Licence No. V02-4883898 for Taxicab Plate No. 1364 to remain in the Estate of Joseph Kay until July 28, 2020.

(Randi Kay-Leifer attended on behalf of Ms Kay.)

2. Zishan Zakria Malik (Report No. 7242) Applicant for a Tow Truck Driver's Licence (Application No. B918085)

DECISION:

The Tribunal approved the dismissal of Mr. Malik's application for a Tow Truck Driver's Licence. Mr. Malik abandoned his application.

(Mr. Malik failed to attend today's hearing.)

3. Balasuntheram Gangatheran (Report No. 7136) Holder of Vehicle-For-Hire Driver's Licence No. D01-4834490

DECISION:

The Tribunal approved the request for adjournment to January 9, 2020.

Mr. Gangatheran contacted Tribunal staff on November 27, 2019 and requested an adjournment as he is unable to attend on November 28, 2019.

(Mr. Gangatheran did not attend today's hearing.)

4. Jeremy Shanahan Karkada (Report No. 7217) Holder of Tow Truck Driver's Licence No. D09-4862872

DECISION:

The Tribunal approved the request for adjournment to January 9, 2020. MLS requested an adjournment of this matter for administrative purposes.

(Mr. Karkada failed to attend today's hearing.)

5. Joon Kyoung Kim (Report No. 7234) Applicant for a Tow Truck Driver's Licence (Application No. B913143)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on November 5, 2019.

Tow Truck Driver's Licence will be issued, subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of three (3) years. Mr. Kim is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Kim and conduct other investigations, as appropriate, to assess Mr. Kim's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Kim must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Kim or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7234 and any updating material, may be brought back before the Tribunal for a full hearing.

6. Pirasanth Loganathan (Report No. 7313) Applicant for a Tow Truck Driver's Licence (Application No. B929814)

DECISION:

The Tribunal ordered a Tow Truck Driver's Licence be issued to Mr. Loganathan, subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of three (3) years. Mr. Loganathan is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Loganathan and conduct other investigations, as appropriate, to assess Mr. Loganathan's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Loganathan or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7313 and any updating material, may be brought back before the Tribunal for a full hearing.
