# TORONTO LICENSING TRIBUNAL: November 21, 2019 Summary of Decisions M. Lee / A. Bakshi / E. Montigny

**1.** Atif T. Mekheal (Report No. 7349) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B942685)

## **DECISION:**

The Tribunal denied Atif T. Mekheal's application for a Vehicle-For-Hire Driver's Licence.

**2.** Idriss A. Hassan (Report No. 7246) Holder of Vehicle-For-Hire Driver's Licence No. D05-4065936

### **DECISION:**

The Tribunal adjourned this matter to December 12, 2019, peremptory to Mr. Hassan.

(Mr. Hassan failed to attend today's hearing.)

**3. Balwinder S. Bains** (Report No. 7275) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B934898)

### **DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on October 22, 2019.

Vehicle-For-Hire Driver's Licence will be issued, subject to the following conditions;

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;

- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Mr. Bains is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Bains and conduct other investigations, as appropriate, to assess Mr. Bains' compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next two (2) renewal(s) of the licence, Mr. Bains must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Bains or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7275 and any updating material, may be brought back before the Tribunal for a full hearing.
- **4. Jimmy Jay John Robert Moore Lungley** (Report No. 7306) Applicant for a Tow Truck Driver's Licence (Application No. B942655)

### DECISION:

The Tribunal ordered that a Tow Truck Driver's Licence be issued to Mr. Lungley, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Tow Truck Driver's Licence will be issued and immediately suspended for a period of 90 days. During this period, Mr. Lungley must surrender his licence and photo ID to MLS on the first day of suspension;
- (3) During the suspension period, if there are any new charges under the Criminal Code, Highway Traffic Act and/or Compulsory Automobile Insurance Act, the applicant must notify MLS of the new charges in writing within 24 hours, the notification must include the licence number and nature of the charges and can be done in any one of the following ways:
  - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via email to: mlsconditionreporting@toronto.ca; or
  - via fax at 416-392-3102

This does not include the charges that are contained in Report No. 7306

and relevant updates;

(4) Should there be any new charges during the suspension period, the Tribunal orders that MLS cancel Mr. Lungley's Tow Truck Driver's Licence, effective immediately.

If Mr. Lungley successfully completes the 90 day suspension period (ending on February 21, 2020 at 12:00 p.m.) with no new charges, his Tow Truck Driver's Licence will be returned and he will be subject to the following conditions;

- (1) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of three (3) years. Mr. Lungley is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Lungley and conduct other investigations, as appropriate, to assess Mr. Lungley's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (2) Prior to each of the next three (3) renewals of the licence, Mr. Lungley must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Lungley or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7306 and any updating material, may be brought back before the Tribunal for a full hearing.
