TORONTO LICENSING TRIBUNAL: December 19, 2019 Summary of Decisions A. Bakshi / M. Lee / D. Simon

1. Muhammad Ahmad Iqbal (Report No. 6311) Holder of Taxicab Driver's Licence No. D01-3953893

DECISION:

The Tribunal adjourned this matter sine die and ordered the interim suspension imposed on December 15, 2016 to remain in effect. Mr. Iqbal must contact Municipal Licensing and Standards regarding the outcome of the charges currently before the court.

 Estate of Joseph Marmorstein (Report No. 7397) Mitch Grossman, Appointed Estate Trustee without a Will Holder of Taxicab Owner's Licence Nos. V02-4966694, V02-4966695 and V02-4966696; Taxicab Plate Nos. 1540, 1986 and 3135

DECISION:

The Tribunal approved an extension of Taxicab Owner's Licence Nos. V02-4966694, V02-4966695 and V02-4966696 for Taxicab Plate Nos. 1540, 1986 and 3135 to remain in the Estate of Joseph Marmorstein until June 30, 2020.

3. Anthony Owusu (Report No. 7285) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B940837)

DECISION:

The Tribunal approved the joint Proposed Resolution signed on December 19, 2019.

Vehicle-For-Hire Driver's Licence will be issued, subject to the following conditions;

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;

- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Owusu is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Owusu and conduct other investigations, as appropriate, to assess Mr. Owusu's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Owusu or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7285 and any updating material, may be brought back before the Tribunal for a full hearing.
- 4. Estate of Keith Orlando Bogle (Report No. 7401) Yvonne Jaycenth Bogle, Estate Trustee Jason Emile Bogle, Signing Authority Holder of Taxicab Owner's Licence No. V02-4811918, Taxicab Plate No. A456

DECISION:

The Tribunal approved an extension of Taxicab Owner's Licence No. V02-4811918 for Taxicab Plate No. A456 to remain in the Estate of Keith Orlando Bogle until February 29, 2020.
