Applicant for the Renewal of Public Garage Licence No. B68-4312909

DECISION:

The Tribunal approved the request for adjournment to March 12, 2020, on consent.

Ms Karen Bernofsky, Solicitor for 2138971 Ontario Inc. requested an adjournment.

- 2. Balasuntheram Gangatheran** (Report No. 7136)
Holder of Vehicle-For-Hire Driver's Licence No. D01-4834490

DECISION:

The Tribunal approved the joint Proposed Resolution signed on January 9, 2020.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Gangatheran is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Gangatheran and conduct other investigations, as appropriate, to assess Mr. Gangatheran's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Balasuntheram Gangatheran or any other concerns with respect to the conduct of the licensee, those matters and report no. 7136 and any updating material, may be brought back before the Tribunal for a full hearing.

3. Jeremy Shanahan Karkada (Report No. 7217)
Holder of Tow Truck Driver's Licence No. D09-4862872

DECISION:

The Tribunal approved the withdrawal of Report No. 7217 by Municipal Licensing and Standards.

Licence No. D09-4862872 expired on September 14, 2019. Municipal Licensing and Standards did not receive the renewal payment, and therefore the licence was cancelled.

4. Kwadwo Mensah Obeng (Report No. 7237)
Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-2020249

DECISION:

The Tribunal approved the renewal of Mr. Obeng's Vehicle-For-Hire Driver's Licence, without conditions.

5. Pietro Puma (Report No. 7250)
Applicant for the Renewal of Tow Truck Driver's Licence No. D09-3117805

DECISION:

The Tribunal approved the joint Proposed Resolution signed on January 9, 2020.

Tow Truck Driver's Licence will be renewed, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Tow Truck Driver's Licence will be placed on probation for a period of Three (3) year(s). Mr. Puma is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr.

Puma and conduct other investigations, as appropriate, to assess Mr. Puma's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;

- (3) Prior to each of the next Three (3) renewal(s) of the licence, Mr. Puma must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Puma or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7250 and any updating material, may be brought back before the Tribunal for a full hearing.

6. Gulam Rahman Choudhury (Report No. 7236)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-3594051

DECISION:

The Tribunal approved the joint Proposed Resolution originally signed on December 10, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's [sic] will be placed on probation for a period of two (2) years. Mr. Choudhury is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Choudhury and conduct other investigations, as appropriate, to assess Mr. Choudhury's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Choudhury or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7236 and any updating material, may be brought back before the Tribunal for a full hearing.
