Thank you for providing me with the Donor Declaration Form for the above-referenced Council Member-Organized Community Event.

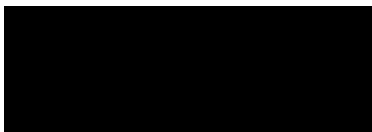



Donations in-kind of a consumable nature will not qualify for an income tax receipt.
