Summary of Decisions

D. Simon / M. Laverty / V. Francis

1. **Sean Patrick Gordon Dalton** (Report No. 7324)
Applicant for a Tow Truck Driver's Licence (Application No. B946043)

DECISION:

The Tribunal approved the joint Proposed Resolution signed on January 16, 2020.

Tow Truck Driver's Licence will be issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Tow Truck Driver's Licence will be placed on probation for a period of five (5) year(s). Mr. Dalton is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Dalton and conduct other investigations, as appropriate, to assess Mr. Dalton's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next five (5) renewal(s) of the licence, Mr. Dalton must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Dalton or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7324 and any updating material, may be brought back before the Tribunal for a full hearing.

2. Ramesh Ajodha Seenath (Report No. 7255)

Applicant for the Renewal of Taxicab Owner's Licence No. V02-0043758,
Taxicab Plate No. 3038

AND

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B923581)

DECISION:

The Tribunal approved the request for adjournment of Mr. Seenath's Application for the Renewal of Taxicab Owner's Licence No. V02-0043758, Taxicab Plate No. 3038 to April 16, 2020, on consent.

The Tribunal further approved the following:

Vehicle-For-Hire Driver's Licence will be issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Seenath is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Seenath and conduct other investigations, as appropriate, to assess Mr. Seenath's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Seenath must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Seenath or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7255 and any updating material, may be brought back before the Tribunal for a full hearing.

3. Fasial Ashraf (Report No. 7394)
Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B979388)

DECISION:

The Tribunal approved the joint Proposed Resolution signed on January 16, 2020.

Vehicle-For-Hire Driver's Licence will be issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of four (4) year(s). Mr. Ashraf is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Ashraf and conduct other investigations, as appropriate, to assess Mr. Ashraf's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next four (4) renewal(s) of the licence, Mr. Ashraf must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Ashraf or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7394 and any updating material, may be brought back before the Tribunal for a full hearing.
