TORONTO LICENSING TRIBUNAL: February 20, 2020
Summary of Decisions

1. Guna Selliah (Report No. 7263)

Holder of Vehicle-For-Hire Driver's Licence No. D01-4915743

DECISION:

The Tribunal ordered the adjournment of this matter to February 27, 2020, peremptory to Mr. Selliah. The Tribunal further ordered Mr. Selliah's licence be suspended on an interim basis for 1 week until this matter is before the Tribunal on February 27, 2020 for a hearing.

Mr. Selliah advised Tribunal staff that he is unable to attend today's hearing due to a conflict and requested an adjournment to February 27, 2020.

3. Anwar Taha Omer (Report No. 7223)
Holder of Vehicle-For-Hire Driver's Licence No. D01-4653642

DECISION:

The Tribunal ordered an adjournment of this matter sine die, pending the final disposition of the criminal charges.

The Tribunal further ordered Mr. Omer will continue to maintain his licence during this interim period, subject to the following conditions;

- (1) If there are any new complaints or charges under the Criminal Code of Canada, Highway Traffic Act or any other legislation, the matter will be brought back to the Tribunal before this constituted hearing panel;
- (2) During this interim period, if there are any new complaints or charges, Mr. Omer must notify Municipal Licensing and Standards of the new complaints or charges in writing within 24 hours. The notification must include his licence number and the nature of the complaints or charges in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to: mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (3) If Municipal Licensing and Standards has any new concerns or any new complaints, charges or convictions against Mr. Omer or any other concerns with respect to the conduct of the licensee, those matters and any updating material, may be brought back before the Tribunal for a hearing;
- (4) Upon notification of any new complaints or charges, Municipal Licensing and Standards will immediately suspend Mr. Omer's licence on an interim basis until that matter can be brought back before the Tribunal for a hearing.

The hearing panel is seized of this matter.
