# TORONTO LICENSING TRIBUNAL: January 30, 2020 Summary of Decisions V. Francis / D. Simon / M. Lee

**1. Baldev Singh** (Report No. 7330) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B948710)

## **DECISION:**

The Tribunal approved the request for adjournment by Mr. Robert Stewart, Paralegal for Mr. Singh. The Tribunal further ordered this matter be held sine die. Mr. Stewart is required to consult with his client and to notify Tribunal Administration of his availability.

An Urdu interpreter will be provided.

2. Anwar Taha Omer (Report No.7223) Holder of Vehicle-For-Hire Driver's Licence No. D01-4653642

### **DECISION:**

The Tribunal approved the request for adjournment of this matter to February 6, 2020, in order for Mr. Omer to retain legal counsel.

 James Robert Leadbeater (Report No. 7228) Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4691980

### **DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on January 14, 2020.

Tow Truck Driver's Licence will be renewed, subject to the following conditions:

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;

- (2) Immediately upon being renewed, Tow Truck Driver's Licence will be placed on probation for a period of two (2) year(s). Mr. Leadbeater is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Leadbeater and conduct other investigations, as appropriate, to assess Mr. Leadbeater's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next two (2) renewal(s) of the licence, Mr. Leadbeater must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Leadbeater or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7228 and any updating material, may be brought back before the Tribunal for a full hearing.
- **4. Bile Dore** (Report No. 7340) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B957874)

### **DECISION:**

The Tribunal approved the withdrawal of Report No. 7340 by Municipal Licensing and Standards.

Mr. Dore provided a letter dated January 9, 2020 requesting the cancellation of his application.
