TORONTO LICENSING TRIBUNAL: March 5, 2020 Summary of Decisions M. Laverty / A. Bakshi / E. Montigny

1. Agim Kastrati (Report No. 7196)

Holder of Tow Truck Driver's Licence No. D09-4878956

DECISION:

The Tribunal approved the request for adjournment to April 16, 2020, pending availability of the Licensees Legal Counsel.

Municipal Licensing and Standards requested an adjournment in order to obtain further documentation.

(Ms Dawn Arnome, agent for Ms Rhonda Fleming, Paralegal and Mr. Kastrati attended today's hearing.)

2. Naim George Iskandar Freij (Report No. 7283) Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D05-4647666

DECISION:

The Tribunal approved the joint Proposed Resolution signed on March 5, 2020.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Vehicle-For-Hire Driver's Licence will be renewed and suspended for five (5) days, starting at 12 pm on Friday, March 13th, 2020 until March 18th, 2020 after 12 pm. Mr. Freij must surrender his Vehicle-For-Hire Driver's Licence and photo card to Municipal Licensing and Standards on the first day of the suspension;

- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Mr. Freij is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Freij and conduct other investigations, as appropriate, to assess Mr. Freij's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) Prior to each of the next two (2) renewal(s) of the licence, Mr. Freij must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Freij or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7283 and any updating material, may be brought back before the Tribunal for a full hearing.

3. Mathew Owusu-Afriyie (Report No. 7321)

Holder of Vehicle-For-Hire Driver's Licence No. D01-2019767

DECISION:

The Tribunal approved the joint Proposed Resolution signed on March 5, 2020.

Vehicle-For-Hire Driver's Licence will be subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Vehicle-For-Hire Driver's Licence will be renewed and suspended for two (2) day(s). Mr. Owusu-Afriyie must surrender his licence and photo card to Municipal Licensing and Standards on Monday, March 9th, 2020 at 8:30 am until Wednesday, March 11th, 2020 at 8:30 am;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) year(s). Mr. Owusu-Afriyie is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Owusu-Afriyie and conduct other investigations, as appropriate, to assess Mr. Owusu-Afriyie's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

- (4) Prior to each of the next three (3) renewal(s) of the licence, Mr. Owusu-Afriyie must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Owusu-Afriyie or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7321 and any updating material, may be brought back before the Tribunal for a full hearing.
- 4. Yoel Dawit Amaha (Report No. 7332) Holder of Vehicle-For-Hire Driver's Licence D01-4957559

DECISION:

The Tribunal ordered the adjournment of this matter to March 26, 2020.

The Tribunal further ordered that the Notice of Hearing and a copy of the full Report, No. 7332 be sent by registered mail and a copy of the Notice of Hearing be sent by regular mail to Mr. Amaha.

Tow Truck Owner's Licence and Tow Truck Driver's Licence will be renewed, subject to the following conditions;

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 45 days of the Tribunal hearing, failing which the licences may be cancelled;

- (2) Immediately upon being renewed, the licences will be placed on probation for a period of two (2) year(s). Mr. Figliomeni is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the corporation and/or Mr. Figliomeni and conduct other investigations, as appropriate, to assess the licensee's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against the licensees or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7238 and any updating material, may be brought back before the Tribunal for a full hearing.
