### Road Resurfacing and Safety Improvements on Shaw Street from Dewson Street to Dupont Street

Contract: 20ECS-TI-14LR Start Date: May 11, 2020 End Date: June 30, 2020 \*Timeline is subject to change.

The City of Toronto will resurface the road on Shaw Street from Dewson Street to Dupont Street. Our inspection of the road shows that it needs resurfacing and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair.

The work will also include implementing a number of safety improvements on Shaw Street from Harbord Street to Dupont Street, including new cycling infrastructure, signage for changes in traffic direction, parking and pavement markings. The improvements on Shaw Street are aimed at reducing cut-through motor vehicle traffic and making it safer for people of all ages and abilities to walk and cycle. Please note that you may receive more than one Construction Notice from the City of Toronto, as there are a number of projects planned in the vicinity of Shaw Street in 2020.

This work is part of the Council-approved 2020 Capital Works Program to renew aging city roads and sidewalk for current and future needs.

#### **IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO**

The Province of Ontario has enacted a declaration of emergency to help contain the spread of COVID-19 and protect the public. A list of essential workplaces in Ontario was announced on March 23 and revised on April 3. As indicated on the list, City-led infrastructure construction has been deemed essential and this project will proceed. This construction is essential to ensure the City's infrastructure remain safe, in a state of good repair and able to meet Toronto's needs. The City's contractor will:

- Dig up the road surface
- Re-align maintenance holes and catch basins
- Repair curbs, gutters and driveways
- Repave the road surface
- Install new parking and traffic direction signage
- Repaint road markings

#### WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.

8	<b>Traffic Management:</b> Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets. Traffic will be reduced on streets with active construction/access may be limited when paving operation are taking place.
$\mathbb{R}$	<b>Parking:</b> Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call <b>416-808-2222</b> for its location.
	This project will affect the availability of on-street parking on Shaw Street. Throughout the duration of construction residents are asked to park on neighbouring streets and to clearly display this Construction Notice on their vehicle dashboards.
	<ul> <li>Parking Violation Notice: In an effort to reduce ticketing due to construction, the City encourages communities with construction to be patient as neighbours may need to temporarily relocate vehicles. If enforcement is called, enforcement must issue a yellow parking violation notice (ticket). If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:</li> <li>1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.</li> <li>2) Dispute the parking violation notice online or in person following the process listed on the reverse side of the parking violation notice.</li> </ul>
	You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note: that violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).
	Garbage and Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. <i>Please ensure that you label your bins with your address.</i>
<b>.</b>	Restoration: Areas affected by construction will be restored.

	<b>Work Hours</b> : Work will take place from 7 a.m. to 7 p.m., Monday to Friday; 9 a.m. to 7 p.m. Saturdays, with work after hours and on Sundays as required.	
Ġ	Accessible Accommodation: Residents who require accommodation (level entry, longer notice, etc.) must contact the Public Consultation Unit to arrange for access during the construction period.	
	<b>Physical Distancing:</b> There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, exterior pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing.	
	Where possible, a phone number for a contact person on-site will be provided on notices, to answer questions about work near your property. At other times, the contractor may knock on your door, but will then step away the required distance to discuss the work that is taking place and what can be expected that day. Please practice physical distancing with workers so everyone can remain safe. If you have questions, call the contact provided on this notice.	
	Important information for owners of sprinkler systems / heated driveways and private landscaping features. Property owners should remove items located within City property limits (boulevard) to avoid damage.

	Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.	
	<b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.


