Watermain Replacement on Cambridge Avenue from Chester Hill Road to Danforth Avenue and Local Streets

Contract: 20ECS-LU-18SU

Expected Start Date: June 2020

Expected End Date: June 2021

The City of Toronto is planning to replace the watermain, the City-owned portion of substandard water services and resurface the road on Cambridge Avenue from Chester Hill Road to Danforth Avenue. The City will also replace the watermain on Dartford from Cambridge Avenue to End, Doncrest Street from Cambridge Avenue to End, and Ozark Crescent from Cambridge Avenue to End.

The water service is the underground pipe that brings water to your water meter and is owned by you and by the City. The part you own is from your house to the end of your property, the part the City owns is from the end of your property to the watermain. Our inspection of the road also shows that it needs reconstruction and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair.

This project is part of the Council-approved 2020 Capital Works Program to renew our aging infrastructure, improve water distribution, reduce the risk of watermain breaks and to renew aging city roads and sidewalk for current and future needs.

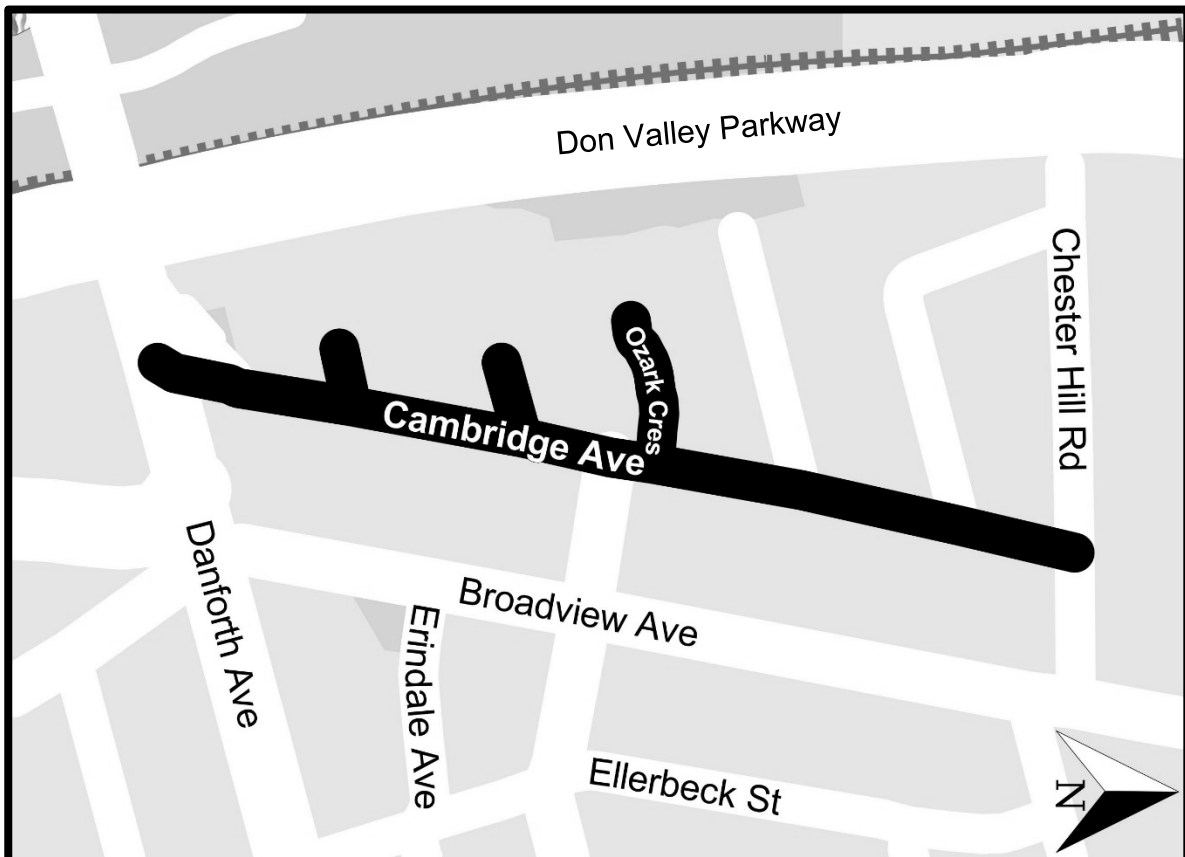
IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

The Province of Ontario has enacted a declaration of emergency to help contain the spread of COVID-19 and protect the public. A list of essential workplaces in Ontario was announced on March 23. IMPORTANT INFORMATION ABOUT LEAD WATER SERVICES



If you live in a house on Cambridge Avenue in the area described above that was built before the mid-1950s, your water service may be made of lead. Please read the attached fact sheet with important information about the risks of lead in drinking water, especially if someone in your house is pregnant, there are children under six years old, or there is an infant drinking formula made using tap water.

WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.
- Work in the boulevard in front of homes and commercial properties is expected. This work includes removing and replacing driveways, municipal sidewalks and grassed boulevards, where necessary.
- Property owners should remove items located within City property limits (boulevard), such as landscaping and or decorative objects before work starts. If you have a sprinkler system within the boulevard, please contact the Field Ambassador listed below.

We recommend you obtain several quotes and you can contact the City's contractor for one of your quotes. Access to "EXTERIOR OF" Your Home: The City-hired contractor may need access to your home to complete a pre-construction survey. Affected properties will receive a pre-construction survey request to schedule a time to complete the survey.
