This forum was meant to be their biggest event ever; with 500+ industry leaders from across the United States of America (and the world) converging upon Chicago for the USA Think Global Conference and USA Think Global Awards. These two events were also be combined with the Council's Inbound Trade Mission to Chicago, consisting of 50+ CEO's of firms visiting from 28 countries. The program was also expanded to include several networking opportunities.

The Experience & Highlights: The Think Global Forum & Conference did not quite hit the target

on the number of delegates – approx. 150-200 delegates may have been in attendance and it was hard to monitor as there seemed to be two separate events taking place at the same time. None-the-less, the event did offer an opportunity for the Alliance to present on the benefits of investing and growing in Ontario.

I also benefitted from having a chance to experience Chicago and to see their waterfront redevelopment as well as Industrial repurposing of some of the Industrial buildings, including the Conference location at the Chicago Green Exchange, a sustainable and green retail and office development project in the Logan Square community area of Chicago.
