### Curb Reconstruction on Government Road from Mill Cove to Walford Road

Contract: 18ECS-TI-14LR Start Date: July 13, 2020 End Date: August 13, 2020 \*Timeline is subject to change.


The City of Toronto will replace the asphalt curb on Government Road from Mill Cove to Walford Road (see map). Our inspection of the curb shows that it needs to be replaced as part of the City of Toronto's ongoing commitment to improving City-owned stormwater management infrastructure. The new concrete curb and gutter will provide improved drainage conditions.

This work is part of the Council-approved 2018 Capital Works Program to renew aging city roads and sidewalk for current and future needs.

### IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

As restrictions on construction have been lifted by the Province of Ontario, City-led infrastructure will continue to proceed. During construction, the contractor is responsible for the Health & Safety on site under the Ontario Occupational Health and Safety Act and is expected to implement COVID-19 mitigation practices. #### WORK DETAILS

The City's contractor will:

- Remove the existing asphalt curb
- Re-align catch basins and install concrete curb and gutter
- Repair affected driveways
- Repave the edge of the road

## **Construction Notice**

	<b>Work Hours</b> : Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.
<sup>(</sup> (	<b>Telephone and Internet Services:</b> This work may affect phone and internet cables for individual properties that aren't buried deep below the sidewalk. The contractor will coordinate with utility companies to minimize disruption. Residents who find their service has been disrupted should contact the <b>Field Ambassador</b> <u>and</u> notify their phone or internet service provider.
÷	<b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.
	<b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.
8	<b>Traffic Management</b> : Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.
	Traffic will be reduced on streets with active construction/access may be limited when paving operations are taking place.
$(\mathbb{R})$	<b>Parking:</b> Parking in the active work zone is not permitted as space is needed for construction equipment and materials. This project will affect on-street parking. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call <b>416-808-2222</b> for its location.
	<ul> <li>Parking Violation Notice: In an effort to reduce ticketing due to construction, the City encourages communities with construction to be patient as neighbours may need to temporarily relocate vehicles. If enforcement is called, enforcement must issue a yellow parking violation notice (ticket). If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:</li> <li>1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.</li> <li>2) Dispute the parking violation notice online or in person following the process listed on the reverse side of the parking violation notice.</li> </ul>
	You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note: violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).
	<b>Garbage and Recycling</b> : Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. <i>Please ensure that you label your bins with your address.</i>
	<b>Restoration:</b> The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October). Residents are encouraged to water newly installed sod to ensure its survival.

**Important information for owners of sprinkler systems / heated driveways and private landscaping features.** Property owners should remove items located within City property limits (boulevard) to avoid damage.
