1. Yemane Kidane (Report No. 7363)

Holder of Vehicle-For-Hire Driver's Licence No. D01-4703551 AND

Holder of Tow Truck Driver's Licence No. D09-4733370

DECISION:

The Tribunal approved the joint Proposed Resolution, on consent.

- A. Mr. Kidane's application for the Renewal of his Vehicle-For-Hire Driver's Licence will be cancelled and his licence will not be renewed:
- B. Mr. Kidane's Tow Truck Driver's Licence will be subject to the following conditions:
 - Mr. Kidane's Tow Truck Driver's Licence will be suspended for seven (7) days from the date this proposed resolution is accepted by the Toronto Licensing Tribunal;
 - (2) Mr. Kidane will complete the Salvation Army Alcohol Abuse Program and will provide proof of its completion to MLS, to its satisfaction, by July 30, 2020;
 - (3) Mr. Kidane will provide proof to MLS, to its satisfaction, by July 30, 2020 that his criminal charge of 'Impaired Operation over 80 mg' of August 24, 2019 has been resolved to the satisfaction of the Crown and that a term of its resolution includes the installation of an interlock device for 11 months on any vehicle he may operate;
 - (4) Mr. Kidane's Tow Truck Driver's Licence will be placed on probation for a period of three (3) year(s). During the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Kidane and conduct other investigations as appropriate to assess his compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;

- (5) Prior to each of the next three (3) renewal(s) of the Tow Truck Driver's Licence, Mr. Kidane must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Kidane or any other concerns with respect to the conduct of the licensee, those matters and Report 7363 and any updating material, may be brought back before the Tribunal for a full hearing.

The Tribunal further ordered that the Proposed Resolution be signed by all parties.
