Purpose	To obtain authority to enter into a Crane Swing Agreement, with XO Residences Inc. (the "Licensee") to permit the Licensee to allow the boom of a crane to swing over part of a City property municipally known as the Dufferin-King Parkette, to facilitate the Licensee's construction of a condominium tower (the "Project") on adjacent property at 1221 King Street West.
Property	The lands described as LT 22 PL 431 PARKDALE; PT LT 21 PL 431 PARKDALE PT 1 TO 7 63R1761, 63R1761; S/T CA12074; CITY OF TORONTO, municipally known as the Dufferin-King Parkette (the "City Lands") (See Appendix "B", location map).
Actions	1. Authority be granted to enter into the Crane Swing Agreement (the "Agreement") on the terms and conditions set out in Appendix "A" with such revisions thereto and any other or amended terms and conditions as may be determined by the Director of Real Estate Services, and in a form acceptable to the City Solicitor;
Financial Impact	The City will receive monthly license fee revenues of \$2,379.35 (plus HST), payable on the first (1 st) of each and every month of the term. Total compensation to the City for the seventeen (17) month term of the agreement will be \$40,448.95 (plus HST). If the Licensee exercises its option to extend, the City will receive additional monthly licence fee revenues for up to an additional twelve (12) months, for a total maximum potential value of \$69,001.15 (plus HST). The Chief Financial Officer and Treasurer has reviewed this DAF and agrees with the financial impact information.
Comments	The Licensee requested permission to swing a crane over a portion of the City Lands having an above ground area of approximately 4,392.64 square feet, being the Licensed Area shown hatched in orange on the sketch attached hereto as Appendix "C". The Licence period is from August 1, 2020 until December 31, 2021 with an option for monthly extensions for up to an additional 12 month period ending no later than December 31, 2022. Real Estate Services staff consider the proposed Agreement to be fair and reasonable to both parties.

General Conditions ("GC")

- (a) The local Councillor (or local Councillors if the subject property is located on a ward boundary or if the transaction involves an exchange of properties in more than one ward), will be consulted prior to the exercise of delegated Approving Authority by staff for all Acquisitions, Disposals, Land Exchanges and Leases. In the event of a vacancy in the Ward in which the subject property is located, the Mayor's office shall be consulted in the alternative.
- (b) Where approving power has been delegated to staff, the Deputy City Manager, Corporate Services, in consultation with any other applicable Deputy City Manager or the City Manager, may determine that such matter is of such special interest that same should be returned to the relevant Committee and Council for consideration and determination.
- (c) Exercise of delegated authority is subject to all applicable Council policies, statutes or other applicable law.
- (d) Authority to approve financial commitments/expenditures is subject to all amounts being available in an approved budget, or funding being available from third party sources, except for "Strategic Property Acquisitions" as set out in EX44.22 adopted by Council August 25, 26, 27 and 28, 2014, which identifies alternative funding mechanisms subject to additional approval requirements.
- (e) Property interests are to be based on appraised market value and no interest shall be granted for an amount less than the appraised market value, nor additional compensation paid, unless specifically authorized by City Council.
- (f) Authority to approve any transaction is subject to statutory anti-bonusing provisions.
- (g) Total compensation means the aggregate of all types of payments, including land value, estimated clean-up costs, potential arbitration awards, loss claims, etc., but exclusive of any applicable taxes and registration costs.
- (h) Authority to acquire property is conditional upon provision being made to bring the property into compliance with applicable MOE or other requirements such that it will be fit for its intended municipal purpose, except for property acquisitions of 50M² or less for transit shelter purposes.
- (i) Authority to initiate the permanent road closure process in **A.4** is conditional upon confirmation by the GM of Transportation Services that it is feasible to permanently close the highway.
- (j) Disposal authorities in **A.7** are subject to the property having been declared surplus, and the disposal policy complied with.
- (k) Land exchanges, except for those in **A.8**, may be authorized based on the delegated Approving Authority for disposals in **A.7**.
- (l) Approving Authority with respect to land located in the Designated Waterfront Area as defined in the *Toronto Waterfront Revitalization Corporation Act, 2002* is conditional upon the approval of the Director, Waterfront Secretariat.
- (m) Authority to approve an exchange of land in **A.8** is conditional upon confirmation by the Chief Planner and Executive Director of City Planning, and the GM of Parks, Forestry & Recreation, that the land being exchanged is (i) nearby land of equivalent or larger area, and (ii) of comparable or superior green space utility.
- (n) Approving Authority in **A.9** Leases (City as Landlord) but not Licences (City as Licensor) is limited to periods (including options/renewals) of less than twenty-one (21) years, as leases of 21 years or more may be authorized based on the delegated Approving Authority for disposals in **A.7**.
- (o) Total compensation in leasing matters where the City is landlord (**A.9**) includes the value of tenant improvements if factored into tenant's rental payments.
- (p) Total compensation in leasing matters where the City is the tenant (**A.10**) includes the value of any tenant improvements to be paid by the City.
- (q) Where options/renewals are included in leases, if the renewal rent is to be determined at a date later than the original approval date, total compensation is to be calculated as though all options are exercised, estimating the renewal rent based on the highest rent payable in the first term of the lease.
- (r) Total compensation in leasing matters where the City is landlord (**A.9**) or tenant (**A.10**) is to be calculated from the date of approval pursuant to this delegation (ie. first allowing for the expiry of any prior approvals, whether by Council or a delegated authority).
- (s) Approving Authority in leasing matters includes authority to approve renewals/extensions within the parameters of the delegated Approving Authority.
- (t) Approving Authority includes authority for amendments within the parameters of the delegated Approving Authority, the cumulative total of which may not exceed the delegated financial limit.
- (u) Where proposed additional amounts in **A.13** exceed 10 per cent of the original decision, even if otherwise in compliance with all other conditions, then Approving Authority is transferred upwards to the next more senior level of Approving Authority having the relevant overall financial limit.
- (v) Approving Authority includes authority for all documents necessary to implement the authority, including ancillary agreements, on terms and conditions satisfactory to the Approving Authority, in consultation with the relevant operating Division(s).
- (w) Staff positions referred to in this delegation include successors from time to time.
- (x) Documents are to be in a form satisfactory to the City Solicitor (including indemnity and insurance provisions).
- (y) Delegated signing authorities in **B** are conditional upon the documents having received the City Solicitor's prior "Approval as to Form".
- (z) Authority to use land acquired by the City for parking purposes by the Toronto Parking Authority is conditional upon Council enacting a by-law designating such use.
- (aa) All residential leasing documents shall adhere to the *Residential Tenancies Act, 2006* and any successor legislation.
- (bb) Despite GC(n), Approving Authority in residential leasing matters is not limited to periods of less than twenty-one (21) years and total compensation in residential leasing matters where the City is landlord is to be calculated based on an assumed term of ten years unless the lease term expressly identified therein is longer.
- (cc) Where Approving Authority has been delegated to the Manager level, such authority shall be conditional upon the Manager first having secured the written concurrence of a second Manager within the Real Estate Services Division.
- (dd) Where the City is transacting with a public agency, and such agency requires that an unqualified environmental indemnity be granted by the City, the authority to acquire property includes authority to grant such an indemnity, provided that the Phase I and Phase II environmental site assessments undertaken on behalf of the City have identified no significant environmental impacts or human health threats, with no, or minor action required ("Low Risk").

Appendix "A"- Term Sheet

1. **Term:** Seventeen (17) months (the "Term"), commencing August 1st 2020 (the "Commencement Date") and expiring on December 31st, 2021.
2. **Extension Term:** One (1) option to renew the Term for a further twelve (12) month period (the "Extension Term") on not less than sixty (60) days' notice to the City prior to the expiry of the initial Term.
3. **License Fee:** A monthly fee of \$2,379.35 (plus HST), payable on the first (1st) of each and every month of the Term and extension term.
4. **Use:**

(1) Provided that the Construction Crane is not carrying objects or materials, the Construction Crane shall be allowed to traverse, swing and/or pass through the Licensed Area or over the buildings and other objects from time to time situate on or in the City Lands (hereinafter "encroach upon City Lands") at any time.

(2) In the event that the Licensee wishes to encroach upon the City Lands while the Construction Crane is carrying objects or materials, the prior written consent of the City shall be required. In the event that the City has given prior written consent to allow the encroachment contemplated herein, such encroachment may only take place:



(a) prior to 8:00 am and after 5:00 pm Mondays to Fridays.

(b) when a paid duty officer is retained, at the sole cost of the Licensee, to ensure that no pedestrians, including City of Toronto personnel, are within or beneath the Licensed Area while the Construction Crane is in operation.


The Licensee must comply with all applicable municipal and provincial laws and regulations during the Term of the Agreement, including the Extension Term (if any).

5. **Insurance:** The Licensee will be required to provide Comprehensive General Liability in the amount of \$20 million per occurrence for bodily injury (including death) and property damage. The City will be added as an additional insured.
1. **Indemnity:**
 - A. The Licensee hereby covenants and agrees to indemnify and save the City harmless from and against any and all liabilities, claims, losses, demands, expenses, actions, injuries, damages, causes of action and costs (hereafter the "Claims") whatsoever arising out of or in connection with the Licensee's occupancy or use of the Licensed Area or any operation or work on the Licensed Area.
