Purpose	To obtain authority to enter into a licence agreement (the " <b>Agreement</b> ") with 2269408 Ontario Inc. (the " <b>Owner</b> ") and City of Toronto, hereinafter (the "City"), as the licensee, to allow for the installation, operation and maintenance of on (1) gas probe (hereinafter the " <b>Works</b> ") on the Owner's property (the " <b>Licensed Area</b> "), for the purpose of monitorin soil gas conditions.							
Property	The property municipally known as 55 Riverwood Parkway, Etobicoke, Ontario, legally described as PLAN 4431 PT LOT 4 (Appendix "A").							
Actions	<ol> <li>The City enter into the Agreement with the Owner to access the Licensed Area, commencing August 10, 2020 an ending August 9, 2023, substantially on the major terms and conditions set out below and including such other terms as deemed appropriate by the approving authority herein, and in a form satisfactory to the City Solicitor.</li> </ol>							
Financial Impact	The City will pay a total sum of \$3,000.00 (plus HST), or \$3,052.80 (net of HST recoveries), for the three (3) year tern payable in equal annual instalments of \$1,000.00 (plus HST) or \$1,017.60 (net of HST recoveries). Payments will commence in 2020 and continue each subsequent year, ending in 2022. The below table reflects the total licence expenditures to the City for each fiscal year.

Permitted Use: To install a gas probe in the Licensed Area to monitor soil gas conditions.

Annual Fee: \$1,000.00 (plus HST).

**Termination**: Both parties can early terminate the Agreement upon providing thirty (30) days' prior written notice to the other and the City will decommission the gas probe and restore the lands to its original condition prior to the installation of the gas probe.

Insurance: Liability insurance with a limit of not less than Five Million Dollars (\$5,000,000.00).
