

Rosehill Reservoir Rehabilitation: Watermain Installation & Water Shut Off

Contract: 17ECS-MI-03WA *Timeline is weather dependent and subject to change.

The City of Toronto will tie-in and connect the watermain from Avoca Avenue into David A Balfour Park from **Monday August 24 to Friday September 4, 2020** and will restrict traffic at the Avoca Avenue and Rosehill Avenue intersection. This work will also require a shut-off to the **water supply to #10 and #20 Avoca Avenue** for **one day on Wednesday August 26, from 8 a.m. to 4 p.m.** We appreciate your patience. 
IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

As restrictions on construction have been lifted by the Province of Ontario, City-led infrastructure will continue to proceed. MAP OF WORK AREA

The City's contractor will:

- excavate the road and dig a trench to access and install the new watermain
- install and tie-in the watermain to David A Balfour Park
- restore all areas affected by construction and resurface the road / watermain trench
- flush the water from a nearby hydrant to clean the new watermain
- Pedestrians will be required to cross the street and walk on the grass or follow posted signs.

TORONTO Important: Water Shut-off

Temporary Water Shut-off <u>ONLY</u> at #10 Avoca Avenue & #20 Avoca Avenue



Due to the watermain construction on Avoca Avenue, the City will need to temporarily shut off the water service to #10 and #20 Avoca Avenue only. The temporary water shut-off is for a short period of time. We apologize for the inconvenience.

TEMPORARY WATER SHUT-OFF IS SCHEDULED FOR:

Wednesday August 26 Starting at 8 a.m.

Ending between 12 to 4 p.m.

WHAT TO DO BEFORE YOUR WATER SUPPLY IS SHUT-OFF:

- Please fill as many containers as you may need during the time of water shut off. We recommend that you store tap water in large containers (e.g. bathtub, buckets, jugs, and pots) at least two hours before the shut-off time.
- With pre-filled buckets, during the shut-off period you can flush a toilet and refill the toilet tank manually using one of the buckets.

COMMON QUESTIONS

1. I do not live at #10 or #20 Avoca Avenue, why am I receiving this notice? This Notice is delivered by Canada Post and the Mail Carrier Routes that include addresses on Rosehill Avenue, Pleasant Boulevard or Avoca Avenue also extend into the wider neighbourhood.

2. I do not live at #10 or #20 Avoca Avenue, will my water be shut off too? No, your water will not be shut off. Only the residents who live at #10 and #20 Avoca Avenue will be affected by this water shut off for Rosehill Reservoir Rehabilitation on August 26, 2020.
