# Finchley Road Ditch Remediation


The City's contractor will be returning to Finchley Road to address resident concerns and correct drainage issues in the ditches and culverts. The work will take place between 14 Finchley Road and 24 Finchley Road.

This work is part of the Council-approved 2018 Capital Works Program to renew aging city roads and sidewalk for current and future needs.

#### IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

As restrictions on construction have been lifted by the Province of Ontario, City-led infrastructure will continue to proceed. During construction, the contractor is responsible for the Health & Safety on site under the Ontario Occupational Health and Safety Act and is expected to implement COVID-19 mitigation practices. #### **WORK DETAILS**

The City's contractor will:

- Remove and replace culverts as required to improve drainage
- Remove excess material from the ditch to improve water flow
- Restore affected driveways
- Restore damaged boulevard areas with sod

#### WHAT TO EXPECT DURING CONSTRUCTION

• You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.



## **Construction Notice**

- Property owners should remove items located within City property limits (boulevard), such as landscaping and/or decorative objects. If you have a sprinkler system within the boulevard, please contact the Field Ambassador.
- The City will not be responsible for damage to any privately owned items on City property.



**Work Hours**: Work will take place from 7 a.m. to 7p.m., Monday to Friday, with work after hours and on weekends as required.



**Road and Sidewalk Access:** In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.

**Driveway Access:** The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.



**Traffic Management**: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.

Traffic will be reduced on streets with active construction and access may be limited when paving operations are taking place.



**Parking:** Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at **416-808-2222**.

In the event you receive a traffic ticket for on-street parking during this period of construction, you may choose to dispute your ticket following the process listed on the reverse side of the parking infraction notice. You may use this notice as part of your defence for parking consideration during construction; however, the Field Ambassador does not have the authority to cancel any parking tickets.



**Garbage & Recycling**: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. *Please ensure that you label your bins with your address.* 



**Restoration:** The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only – in the spring (April to June) and fall (September to October).
