Basement Flooding Protection Program on Glenwood Crescent

Contract: 18ECS-LU-04FP

Winter Shutdown Start Date: December 21, 2019 Winter Shutdown End Date: March 30, 2020 *Timeline is subject to change.

The City's contractor has completed sewer upgrades, water service replacements, and curb/sidewalk restoration work on Glenwood Crescent between Glen Gannon Drive and Rexleigh Drive

Following consultation with the community, the City has opted to stop construction during winter months. The construction work on the watermain, storm sewer box culvert, and sanitary sewer will stop when the construction reaches Stag Hill Drive. Work will resume in spring 2020, and a Construction Update will be provided one to two weeks before work re-starts. Below is an overview of the work that will be completed before work stops for the winter. **Note:** *Timeline is subject to change due to weather conditions or unexpected delays.* The City of Toronto thanks you for your patience during necessary basement flooding construction in your area.

Winter Maintenance: Any snow removal up to the winter shutdown on December 21, 2019, will be done by the contractor. Snow removal includes clearing the street and sidewalks within the construction zone, and removing snow on driveways where temporary water and sewer lines are running. After December 21, regular snow removal operations by the City and residents will resume.
Garbage & Recycling: Once the contractor cleans the site, regular curbside garbage pick up will resume.

Winter Site Preparation: All temporary pipes will be removed from driveways, and sidewalks. Pavement will be temporarily restored with asphalt. The contractor will clean the construction area, and remove most of the construction equipment on Glenwood Crescent by December 21. All materials and equipment will be removed from the street and some will be stored in the Glenwood / St. Columba island. The large excavator will be parked off the street at the intersection of Glenwood Crescent and Glenwood Terrace, and the site trailer will remain at its current location on St. Columba Place.




Parking: Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at **416-808-2222**.

Specific details regarding parking for affected properties will be provided by the contractor 48 hours prior to the work starting in front of your property.

In the event you receive a traffic ticket for on-street parking during this period of construction, you may choose to dispute your ticket following the process listed on the reverse side of the parking infraction notice.

You may use this notice as part of your defense for parking consideration during construction; however, the Field Ambassador does not have the authority to cancel any parking tickets.
