Fairbank Silverthorn Basement Flooding Protection Project Phase 1: Inlet Control Devices Installation

Contract: 20ECS-LU-01TT
Expected Start Date: June 2020 Expected End Date: September 2020
*Timeline is subject to change.

The City of Toronto will install Inlet Control Devices (ICDs) at existing road catch basins in the Faribank Silverthorn area; the first 55 ICDs (see map) are being installed in advance to review their performance before installation 500 ICDs for the entire area as part of The Fairbank Silverthorn Basement Flooding Protection Project which also includes constructing a large storm trunk sewer, and new storm sewers.

The ICDs restrict the rain water entering the combined sewer system through the catch basins on road and reduce the risk of combined sewer from being full, thus reducing risk of basement flooding. The ICD installation will increase the temporary surface ponding on the street due to reduced rain water going to the combined sewer.

The project is part of the Council-approved Capital Works Program as part of the City's Basement Flooding Protection Program. The federal Government of Canada has provided \$73.2 million of funding for this project. Major construction activity for this Basement Flooding Protection Project will occur from 2021 to 2025.

WORK DETAILS

- Construction crews will access the catch basin, which they will inspect, clean, and repair as
 necessary. The work planned at each of the 55 catch basins should only take (2 to 4 hours at
 each location), and will take place near the catch basins located at the street edge. Excavation is
 not required for this work.
- The crews will then install the inlet control devices inside the catch basin and put a curb paint mark for identification.

IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

As restrictions on construction have been lifted by the Province of Ontario, City-led infrastructure will continue to proceed. During construction, the contractor is responsible for the Health & Safety on site under the Ontario Occupational Health and Safety Act and is expected to implement COVID-19 mitigation practices. WHAT TO EXPECT DURING CONSTRUCTION

- Some local parking restrictions may be in place to ensure vehicles are not parked over catch
 basins and the contractor can access them. The contractor will coordinate with the home owner, in
 advance, if driveways or on-street parking will be affected.
- You may experience dust, noise, and other inconveniences. The City of Toronto will make efforts to reduce the impact on the residential area. We appreciate your patience.



Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday.



Traffic Management: Road closures are not anticipated. If lanes are restrictied, at least one lane will be kept open to traffic at all times. Temporary signage will be placed to direct traffic around construction zones. So impacts to the road surface and traffic will be minimal.



Physical Distancing

There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, exterior pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing.


