DECISION:

The Tribunal approved the request for adjournment to November 19, 2020, on consent.

The Tribunal further approved the following interim order in respect of business licences No. B50-3846225 and B71-4732161 and the Application for a Retail Store (Food) Licence (Application No. C025573), submitted by both parties, on consent:

- Retail Store (Food) Licence No. B50-3846225, held by 1772858 Ontario Inc. o/a AI Premium Food Mart will be deemed to continue until November 19, 2020.
- (2) Renewal of Eating Establishment Licence No. B71-4732161, held by 2263079 Ontario Inc. o/a Al Premium Food Mart will be deemed to continue until November 19, 2020.
- (3) An interim Retail Store (Food) Licence will issue to 9050027 Canada Inc. o/a Al Premium Foods, to be valid until November 19, 2020 (the "Interim Licence"), subject to the conditions set out herein.

The Tribunal approved the amended item 4, on consent:

(4) All fees, documents and/or outstanding requirements in respect of the Interim Licence must be submitted to the satisfaction of Municipal Licensing and Standards within 7 days of the issuance of an invoice, failing which the Interim Licence may be cancelled.
