Ali Abass (Report No. 7404)
 Applicant for a Vehicle-for-Hire Driver's Licence (Application No. B988359)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on March 10, 2020.

Vehicle-For-Hire Driver's Licence will issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) year(s). Mr. Abass is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Abass and conduct other investigations, as appropriate, to assess Mr. Abass' compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewal(s) of the licence, Mr. Abass must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Abass or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7404 and any updating material, may be brought back before the Tribunal for a full hearing.

2. Faisal Imran (Report No. 7391)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B964235)

DECISION:

The Tribunal approved the joint Proposed Resolution, on consent.

Vehicle-For-Hire Driver's Licence will issued, subject to the following conditions;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards by December 31, 2020, failing which the licence may be cancelled;
- (2) Prior to December 31, 2020, Faisal Imran must submit, to the satisfaction of Municipal Licensing and Standards, proof of completion of a Defensive Driving Course with the Ontario Safety Council in one of the following ways:
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (3) On November 16, 2020, the Vehicle-For-Hire Driver's Licence will be suspended for a period of Ten (10) days;
- (4) The Licence will issue as of the date this proposed resolution is approved by the Tribunal on the understanding that the Licensee is presently in Pakistan and will not be returning to Ontario until the second week of November, 2020. If the Licensee returns to Ontario prior to November, 2020, he must immediately inform Municipal Licensing and Standards by email to mlsconditionreporting@toronto.ca. Municipal Licensing and Standards may then, in its sole discretion, return to the Tribunal to request a further order in respect of this matter, including modification of the suspension commencement date of November 16, 2020 and the deadline by which the defensive driving course must be completed;
- (5) Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) year(s), the commencement of this period being the date on which this proposed resolution is approved by the Tribunal. Faisal Imran is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Faisal Imran and conduct other investigations, as appropriate, to assess Faisal Imran's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
