Prepared By: Patricia Chen Division: Corporate Real Estate Management 416-338-3583 Date Prepared: May 15, 2020 Phone No.: Purpose To obtain authority for the City of Toronto (the "City"), as Licensee, to enter into a short-term licence agreement (the "Agreement") with Malvern Presbyterian Church (the "Church"), as Licensor, for a retroactive period of 39 days commencing January 20th, 2020 and expiring on February 27th, 2020, substantially on the terms and conditions set out below. Property Malvern Presbyterian Church, 1301 Neilson Rd, Scarborough, ON, M1B 3C2 Actions 1. Authority be granted to enter into the Agreement with the Church substantially on the terms and conditions set out below, and including such other terms and conditions as may be satisfactory to the approving authority herein, and in a form satisfactory to the City Solicitor. **Financial Impact** The total cost to the City will be \$13,300 (HST not applicable). Funding is available in the 2020 Council Approved Operating Budget for Toronto Children's Services under cost centre E0552M. The Chief Financial Officer and Treasurer has reviewed this DAF and agrees with the financial impact information. Comments Toronto Early Learning Child Care Centres have emergency management plans in place to ensure that in the case of an emergency at the original location, affected children and staff can be relocated to another location with minimal disruption to ensure continued business operations. The original location of the Centenary Seven Oaks Early Learning and Child Care Centre ("Centenary"), located at 9 Neilson Rd, experienced flooding at their site, rendering the original child care centre unsuitable to continue operations. Consequently, Centenary moved their operations, staff, and children immediately to the Church and commenced operations on January 20th, 2020 with the intention that they would occupy the site for a period of a few weeks, making use of the entire Church except the sanctuary. Due to the emergency nature of the situation, the Church permitted Centenary to move into the licensed premises before the rent could be negotiated. However, an appraisal has since been conducted by the City and the Church has agreed to the terms and conditions of the Agreement set out below, which are considered to be fair, reasonable, and reflective of market value. As a result, authority is being requested to enter into the Agreement retroactively. Going forward, Corporate Real Estate Management and Toronto Children's Services will create a policy governing the costs that should be reasonably spent for short-term emergency arrangements with external organizations. General Conditions ("GC")

- (a) The local Councillor (or local Councillors if the subject property is located on a ward boundary or if the transaction involves an exchange of properties in more than one ward), will be consulted prior to the exercise of delegated Approving Authority by staff for all Acquisitions, Disposals, Land Exchanges and Leases. In the event of a vacancy in the Ward in which the subject property is located, the Mayor's office shall be consulted in the alternative.
- (b) Where approving power has been delegated to staff, the Deputy City Manager, Corporate Services, in consultation with any other applicable Deputy City Manager or the City Manager, may determine that such matter is of such special interest that same should be returned to the relevant Committee and Council for consideration and determination.
- (c) Exercise of delegated authority is subject to all applicable Council policies, statutes or other applicable law.
- (d) Authority to approve financial commitments/expenditures is subject to all amounts being available in an approved budget, or funding being available from third party sources, except for "Strategic Property Acquisitions" as set out in EX44.22 adopted by Council August 25, 26, 27 and 28, 2014, which identifies alternative funding mechanisms subject to additional approval requirements.
- (e) Property interests are to be based on appraised market value and no interest shall be granted for an amount less than the appraised market value, nor additional compensation paid, unless specifically authorized by City Council.
- (f) Authority to approve any transaction is subject to statutory anti-bonusing provisions.
- (g) Total compensation means the aggregate of all types of payments, including land value, estimated clean-up costs, potential arbitration awards, loss claims, etc., but exclusive of any applicable taxes and registration costs.
- (h) Authority to acquire property is conditional upon provision being made to bring the property into compliance with applicable MOE or other requirements such that it will be fit for its intended municipal purpose, except for property acquisitions of 50M² or less for transit shelter purposes.
- (i) Authority to initiate the permanent road closure process in A.4 is conditional upon confirmation by the GM of Transportation Services that it is feasible to permanently close the highway.
- (j) Disposal authorities in A.7 are subject to the property having been declared surplus, and the disposal policy complied with.
- (k) Land exchanges, except for those in A.8, may be authorized based on the delegated Approving Authority for disposals in A.7.
- (I) Approving Authority with respect to land located in the Designated Waterfront Area as defined in the Toronto Waterfront Revitalization Corporation Act, 2002 is conditional upon the approval of the Director, Waterfront Secretariat.
- (m) Authority to approve an exchange of land in A.8 is conditional upon confirmation by the Chief Planner and Executive Director of City Planning, and the GM of
- Parks, Forestry & Recreation, that the land being exchanged is (i) nearby land of equivalent or larger area, and (ii) of comparable or superior green space utility. (n) Approving Authority in A.9 Leases (City as Landlord) but not Licences (City as Licensor) is limited to periods (including options/renewals) of less than twenty-one (21) years, as leases of 21 years or more may be authorized based on the delegated Approving Authority for disposals in A.7.
- (o) Total compensation in leasing matters where the City is landlord (A.9) includes the value of tenant improvements if factored into tenant's rental payments.
- (p) Total compensation in leasing matters where the City is fandioid (A.9) includes the value of any tenant improvements to be paid by the City.
- (p) Total compensation in leasing matters where the city is the tenant (A. 10) includes the value of any tenant improvements to be paid by the city.
 (q) Where options/renewals are included in leases, if the renewal rent is to be determined at a date later than the original approval date, total compensation is to be calculated as though all options are exercised, estimating the renewal rent based on the highest rent payable in the first term of the lease.
- (r) Total compensation in leasing matters where the City is landlord (A.9) or tenant (A.10) is to be calculated from the date of approval pursuant to this delegation (ie. first allowing for the expiry of any prior approvals, whether by Council or a delegated authority).
- (s) Approving Authority in leasing matters includes authority to approve renewals/extensions within the parameters of the delegated Approving Authority.
- (t) Approving Authority includes authority for amendments within the parameters of the delegated Approving Authority, the cumulative total of which may not exceed the delegated financial limit.
- (u) Where proposed additional amounts in A.13 exceed 10 per cent of the original decision, even if otherwise in compliance with all other conditions, then Approving Authority is transferred upwards to the next more senior level of Approving Authority having the relevant overall financial limit.
- (v) Approving Authority includes authority for all documents necessary to implement the authority, including ancillary agreements, on terms and conditions satisfactory to the Approving Authority, in consultation with the relevant operating Division(s).
- (w) Staff positions referred to in this delegation include successors from time to time.
- (x) Documents are to be in a form satisfactory to the City Solicitor (including indemnity and insurance provisions).
- (y) Delegated signing authorities in **B** are conditional upon the documents having received the City Solicitor's prior "Approval as to Form".
- (2) Authority to use land acquired by the City for parking purposes by the Toronto Parking Authority is conditional upon Council enacting a by-law designating such use.
- (aa) All residential leasing documents shall adhere to the Residential Tenancies Act, 2006 and any successor legislation.
- (bb) Despite GC(n), Approving Authority in residential leasing matters is not limited to periods of less than twenty-one (21) years and total compensation in residential leasing matters where the City is landlord is to be calculated based on an assumed term of ten years unless the lease term expressly identified therein is longer.
- (cc) Where Approving Authority has been delegated to the Manager level, such authority shall be conditional upon the Manager first having secured the written concurrence of a second Manager within the Real Estate Services Division.
- (dd) Where the City is transacting with a public agency, and such agency requires that an unqualified environmental indemnity be granted by the City, the authority to acquire property includes authority to grant such an indemnity, provided that the Phase I and Phase II environmental site assessments undertaken on behalf of the City have identified no significant environmental impacts or human health threats, with no, or minor action required ("Low Risk").
