Sanitary Sewer Chamber Rehabilitation on Scott Street, Market Street and Frederick Street

Contract: 19ECS-MI-01SA

Start Date: October 19, 2020 End Date: April 4, 2021

*Timeline is subject to change.

The City of Toronto will rehabilitate three sanitary sewer chambers on Scott Street at The Esplanade, Market Street at The Esplanade, Frederick Street at Front Street, and replace a section of sanitary sewer on Market Street (see map).

In order to address sewer capacity concerns and reduce the stormwater inflow to the sanitary system, the City conducted an inflow and infiltration (I/I) study in the project area and this rehabilitation work is designed to help address those concerns.

This project is part of the Council-approved 2020 Capital Works Program that will improve sanitary system and the City's aging infrastructure.

IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO


As restrictions on construction have been lifted by the Province of Ontario, City-led infrastructure will continue to proceed. During construction, the contractor is responsible for the Health & Safety on site under the Ontario Occupational Health and Safety Act and is expected to implement COVID-19 mitigation practices. WORK DETAILS

The City's contractor will:

- Rehabilitate two sanitary chambers on Scott Street and Frederick Street.
- Excavate the road on Market Street to access, to replace the sanitary chamber and a portion of the sanitary sewer.
- Restore all areas affected by construction and resurface the road on Market Street.

MAP OF WORK AREA







WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.



Work Hours: Work will take place from 7 a.m. to 7 p.m. Monday to Friday, with work after hours and on weekends as required.



Physical Distancing

There are times when contractors need to communicate with business owners and homeowners about what is happening on-site. This could be about driveway access, water shut offs, exterior pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing.

Where possible, a phone number for a contact person on-site will be provided on notices, to answer questions about work near your property. If in-person communication with the contractor is required, the contractor will maintain the required physical distance. Please practice physical distancing with workers so everyone can remain safe. If you have questions, call the contact provided on this notice.



Site Access: In order to complete the work in a safe manner, there may be road and crosswalk restrictions within the construction work zone. Access for emergency vehicles will always be maintained.



Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.



Parking: Parking in the active work zone is not permitted as space is needed for construction equipment and materials. This project will affect on-street parking. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call **416-808-2222** for its location.



Parking Violation Notice: In an effort to reduce ticketing due to construction, the City encourages communities with construction to be patient as neighbours may need to temporarily relocate vehicles. If enforcement is called, enforcement must issue a yellow parking violation notice (ticket). If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:

- 1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.
- 2) Dispute the parking violation notice online or in person following the process listed on the reverse side of the parking violation notice.

You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note: violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).



Restoration: All areas affected by construction will be restored.
