1. Abdi Salam Nur Osman (Report No. 7442)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. C009940)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on October 21, 2020.

Vehicle-For-Hire Driver's Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled:
- (2) The Vehicle-For-Hire Driver's Licence will be placed on probation for a period of one (1) year. Abdi Salam Nur Osman is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Abdi Salam Nur Osman and conduct other investigations, as appropriate, to assess the Abdi Salam Nur Osman's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

The Tribunal ordered an amendment to condition 3, on consent:

- (3) Prior to the next one (1) renewal of the **licence**, Abdi Salam Nur Osman must provide to Municipal Licensing and Standards at his own expense, an original up to date Criminal Record and Judicial matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Abdi Salam Nur Osman or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7442 and any updating material, may be brought back before the Tribunal for a full hearing.

Arshpal Singh (Report No. 7375)
 Holder of Vehicle-For-Hire Driver's Licence No. D01-4827074

DECISION:

The Tribunal proceeded with a hearing on this matter on an ex parte basis, at the request of Municipal Licensing and Standards. The Tribunal was satisfied that Mr. Singh was properly served.

The Tribunal ordered the Vehicle-For-Hire Driver's Licence will be subject to the following conditions:

- (1) Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Arshpal Singh is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Arshpal Singh and conduct other investigations, as appropriate, to assess Arshpal Singh's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (2) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Arshpal Singh or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7375 and any updating material, may be brought back before the Tribunal for a full hearing.
