Road Safety Improvements at the Mount Pleasant Road and Roxborough Drive Intersection

Contract: 20ECS-TI-04LR

Start Date: October 26, 2020 End Date: Spring 2021

**Timeline is subject to change.*

The City will be installing new road safety measures at the intersection of Mount Pleasant Road and Roxborough Drive to create better sight lines for pedestrians and drivers, shorten pedestrian crossing distances and encourage drivers to travel at the speed limit. All measures will be made within the City's right-of-way.

The improvements include:

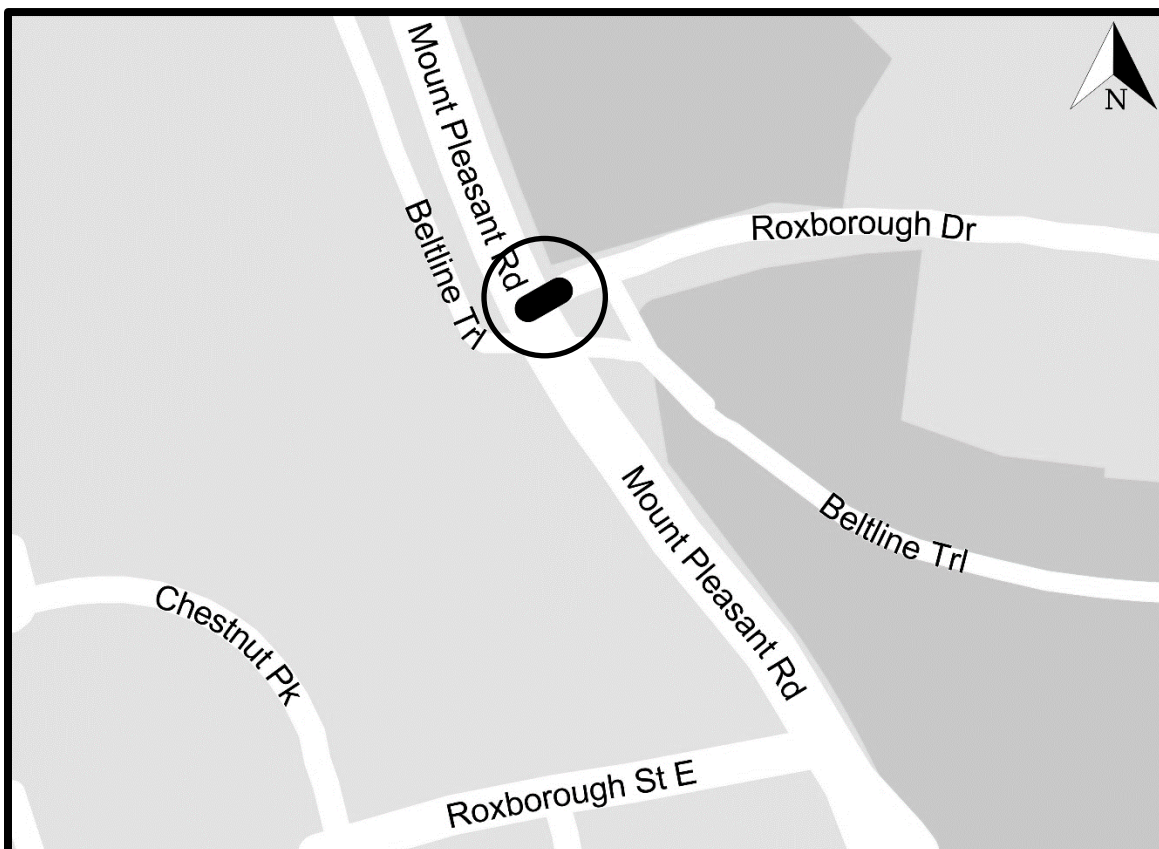
- A new intersection design including traffic signals;
- Reduced curb radii (curved sections at all corners);
- Right-turn channel removal at the southeast corner;
- A new crosswalk installation;
- Road resurfacing; and,
- Pavement markings.

Intersection safety improvements are part of the City's Vision Zero Road Safety Plan which aims to eliminate collisions that result in death and serious injury.

CURB RADII REDUCTIONS	<p>The curb radii is the curved section that connects two intersecting streets.</p> <p>Reducing curb radii can:</p> <ul style="list-style-type: none"> deter drivers from making right turns at high speeds; improve pedestrian crossing distances and visibility; and increase the space available for pedestrians waiting to cross. 	<p>Locations:</p> <ul style="list-style-type: none"> east side of intersection at Roxborough Drive
RIGHT-TURN CHANNEL REMOVAL	<p>The removal of the right-turn channel will help slow northbound right turning motorists.</p>	<p>Locations:</p> <ul style="list-style-type: none"> southeast corner of Mount Pleasant Road and Roxborough Drive intersection





WORK DETAILS




The City's contractor will:

- Dig up the road surface;
- Re-align catch basins and adjustment of maintenance holes;
- Reconstruct curb and gutters;
- Repave the road surface; and
- Install traffic signal and line painting.

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.

	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p>Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.</p> <p>Traffic on Mount Pleasant Road will be reduced to one lane.</p>
	<p>Physical Distancing: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, exterior pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing and will maintain physical distancing. If you have questions, call the contact provided on this notice.</p>

	<p>Site Safety: Workers on site are responsible for the work assigned to them. If you have construction questions or an issue on site – ask to be directed to the site inspector. If the site inspector is unavailable, contact the person listed at the end of this notice.</p>
	<p>Accessible Accommodation: Residents who require accommodation (level entry, longer notice, etc.) must contact the Project Manager to arrange for access during the construction period.</p>
	<p>Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>
