#### Multi-Tenant (Rooming) House Policies, Rules, and Regulations

Multi-tenant houses, commonly known as rooming houses or lodging houses, are only permitted in the former cities of York and Toronto. Multi-tenant houses that operate in Toronto must be licensed.

Multi-tenant houses are dwellings where a kitchen and/or washroom is shared between four or more people who each pay rent. Multi-tenant houses (including bachelorettes) that were created as part of the Parkdale Project are also deemed to be multi-tenant houses under this definition. Fraternity and sorority houses may need to be licensed as multi-tenant houses if they meet the definition of a multi-tenant house.

Personal care multi-tenant houses are where, in addition to dwelling rooms, the owner/operator provides meals and where service is given to residents in caring for their personal needs or health, or both.

The following buildings do not need to be licensed as multi-tenant houses: dwellings licensed and inspected by the provincial or federal government, such as group homes or retirement homes; and cooperative student residences that have more than three bedrooms.

#### Fees

Former City of Toronto

- The fee is \$100 if one or more of these conditions apply:
  - the registered owner occupies living space of 30 square metres or less as their personal residence
  - the multi-tenant house is operated by a non-profit corporation
  - the multi-tenant house has up to three storeys (not including the basement) and contains up to 14 bedrooms, with fewer than four bedrooms on the third storey.

If none of the above conditions apply, then:

- The fee is \$200 if:
  - the multi-tenant house has up to three storeys (not including the basement) and contains up to 14 bedrooms, with four or more bedrooms on the third storey
  - the multi-tenant house has up to three storeys (not including the basement) and more than 14 bedrooms.
- The fee is \$300 if the multi-tenant house has more than three storeys (not including the basement).

#### **Fire Safety Standards**

Owners/operators are required to have a copy of the model Fire Safety Plan drawn up by the Fire Chief; post in a conspicuous location; and use it in the case of a fire.

I, the owner/operator declare that I have a copy of the model fire safety plan drawn up by the Fire Chief.

I, the owner/operator acknowledge that I am responsible for having a fire safety plan for the premises in accordance with the requirements of the Fire Code and to use the model fire safety plan drawn up by the Fire Chief to draw up a fire safety plan for the premises.

I the owner/operator agree to post a fire safety plan, approved by the Fire Chief, in the premises in a conspicuous place.
