DECISION:

The Tribunal approved the request for the withdrawal of the Application for the Renewal of Tow Truck Owner's Licence Nos.: V10-4926921, V10-4926849, V10-4926924, V10-4926852, V10-4926853 and V10-4926571, for Plate Nos. 2293, 2361, 5563, 5804, 5805 and 6261 by Snowcity Roadside Assistance Inc.

The Tribunal further approved the joint Proposed Resolution for Certified Auto Collision Repair Inc., originally signed on December 2, 2020.

Public Garage Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled:
- (2) Upon being issued the Public Garage Licence will be placed on probation for a period of two (2) years. Abdalwahd Mohssentaher El-Taii is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Certified Auto Collision Repair Inc. and Mr. El-Taii and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;

- (3) Prior to each of the next two (2) renewals of the licence, Abdalwahd Mohssentaher El-Taii must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial matters check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Certified Auto Collision Repair Inc. and Abdalwahd Mohssentaher El-Taii or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7396 and any updating material, may be brought back before the Tribunal for a full hearing.
