Signing Authority	Deputy City Manager, Corporate Services has signing authority on behalf of the City for Documents required to implement matters for which he or she also has delegated approval authority.				
Purpose	To obtain authority to enter into a licence extension agreement with Metrolinx (the " Licensee ") with respect to the property municipally known as 3501 Eglinton Avenue West as required for the implementation of the Eglinton Crosstown Light Rail Transit Project (the " Project ") extending the licence term for a period of fifteen (15) months (the " Licence Extension Agreement ").				
Property	Part of 3501 Eglinton Avenue West, shown in Appendix "A", legally described as Part of Block A, Plan 2008 Township of York, Part 4-6 and 12-22 Plan 64R-16308 and Part 3, Plan 64R-16471, City of Toronto, shown as Parts 1, 4-9 on Plan 66R-28073 and Part 8 on Drawing No. 1316471-6_CTS, (shown in Appendix "B").				
Actions	 Authority to be granted to enter into the Licence Extension Agreement with the Licensee, substantially on the terms and conditions outlined below, and including such other terms as deemed appropriate by the approving authority herein, and in a form satisfactory to the City Solicitor. 				
Financial Impact	There is no financial impact resulting from this approval. Pursuant to Schedule F (Real Estate Protocol) contained in the Master Agreement between the City, the Toronto Transit Commission and Metrolinx for the implementation of the Toronto Light Rail Transit Program dated November 28, 2012 (" Master Agreement "), temporary use property requirements not required for City purposes are transferred Metrolinx for nominal consideration.				
	The Chief Financial Officer and Treasurer has reviewed this DAF and agrees with the financial implications as identifi in the Financial Impact section.				
Comments	By adoption of DAF2015-069, authority was granted to enter into a licence agreement with the Licensee for 5-year ter commencing on July 23, 2015 (the " Original Licence ") By adoption of DAF2018 -221, authority was granted to amend the Original Licence to include the additional licensed area. The Original Agreement and the amending agreement are referred collectively as the " Licence "; Metrolinx has requested to extend the Licence for a period of fifteen (15) months from July 24, 2020 to October 23, 2021.				
Terms	All terms and conditions of the Licence Extension Agreement will remain unchanged, except for the licence term which is extended for a period of fifteen (15) months from July 24, 2020 to October 23, 2021.


