

RFP Overview

- RFP to select an Indigenous non-profit housing provider to lease and operate 218 Carleton for 50 years as affordable rental housing
- Property will be fully renovated into approximately 10 bachelors with design input from the Successful Proponent
- The building average rent must be no more than 80% of average market rent (AMR) and no unit rent can be more than 100% AMR
- Supports to tenants by the provider or by Indigenous partners are encouraged

Unit Type & AMRs	2020 Rents
Bachelor 100% AMR	\$1,148
Bachelor 80% AMR	\$918



Proponent Eligibility

Indigenous Non-Profit Housing Providers should apply if:

- They have a track record of operating quality affordable rental housing in a financially sustainable manner
- They have experience providing appropriate support services to proposed tenants or in partnership with Indigenous support providers
- Are prepared to enter into the legal agreements in the RFP and take possession of the property in late 2023

Management Qualifications and Financial Viability

Proponents must demonstrate their ability to operate and maintain good quality affordable rental housing and provide appropriate supports to tenants by including:

- Details of housing projects managed over the last 5 years
- Details of proposed tenant target group(s)
- Details of support services to be delivered to tenants and by whom
- Details of proposed operating budget



Proposal Submission Checklist

- 1. Table of Contents
- 2. Signed Letter of Introduction
- 3. Signed Offer to Lease
- 4. Mandatory Forms 1-5 Appendix 5
- 5. Written response to each sub-section in Sections 6.3 to 6.6 to address the 4 Evaluation Criteria (listed on next slide)



Proposal Evaluation Criteria

	Criteria	Available Points
1	Management Qualifications	30
2	Corporate Financial Viability	20
3	Operating and Management Plan	30
4	Support Services Plan	20
	TOTAL	100



Selection Process

- Proposals must meet eligibility requirements to be evaluated
- Proposals to be evaluated by Housing Secretariat and SSHA staff
- Proposals must score at least 70% to be considered
- Proponents will be notified in writing whether they have been selected for funding or not
- Report recommending a Successful Proponent will be made public a week before the February 22, 2021 Planning and Housing Committee meeting
- Decision of City Council is final
