#### **DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on December 2, 2020.

Commercial Parking Lot Licences will be issued and renewed, subject to the following conditions:

(1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled: December 3, 2020

- (2) Upon those licences being renewed and issued, both newly issued and renewed Commercial Parking Lot Licences and the other existing Commercial Parking Lot Licences will be placed on probation for a period of two (2) years. Aphrodite Kiousis is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Canada Wide Parking Inc. and Aphrodite Kiousis and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Canada Wide Parking Inc. and Aphrodite Kiousis or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7460 and any updating material, may be brought back before the Tribunal for a full hearing.
