The City of Toronto will be replacing the Foxridge Drive Culvert over Massey Creek. This work will ensure that the new structure meets today's standards and remain safe for pedestrians and vehicles in the future.


Due to space constraints at the site, beginning on December 7, 2020, this work will require full road and sidewalk closures of Foxridge Drive at Massey Creek. Only local access will be permitted. A temporary pedestrian bridge will be provided on the south side of the street to maintain pedestrian and cyclist access through the work zone.

MAP OF WORK AREA




WORK DETAILS

In the coming months, the City's contractor will:

- Remove the existing roadway and sidewalks.
- Replace the existing culvert below Foxridge Drive.
- Reconstruct the roadway and sidewalks; and
- Restore the surrounding environment.

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.

	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and weekend work as required.</p>
	<p>Road and Sidewalk Access: Sidewalk access along both sides of Foxridge Drive will be closed during the project. A temporary pedestrian bridge will be erected south of the work zone to maintain pedestrian access and temporary signage will direct pedestrians to safely cross the construction zone.</p> <p>Access to driveways along Foxridge Drive in close proximity to the project will be maintained during the work, but may be impacted during concrete sidewalk construction and/or asphalt paving activities. Alternate parking arrangements will be made for residents impacted by this work.</p> <p>Right turns to/from driveways may be restricted due to the traffic control devices erected during the work. Residents impacted by this will receive additional notice prior to the work.</p>
	<p>Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.</p> <p>Beginning December 7, 2020 until March 25, 2021, Foxridge Drive will be closed to traffic at the work area between Garthwood Drive and Kennedy Road.</p> <p>Detours signage will be in place to direct traffic around the road closure. For northbound motorists on Kennedy Road, access to Foxridge Drive is available by turning left onto Eglinton Avenue East, turning left onto Birchmount Road, and then turning left onto Foxridge Drive.</p> <p>For southbound motorists on Kennedy Road, access to Foxridge Drive is available by turning right onto St Clair Avenue East, turning right onto Birchmount Road, and then turning right onto Foxridge Drive.</p>
	<p>Physical Distancing: There are times when contractors need to communicate with homeowners about work happening nearby. This could be about driveway or sidewalk access, exterior pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing.</p> <p>Where possible, a phone number for a contact person on-site will be provided on notices, to answer questions about work near your property. At other times, the contractor may knock on your door, but will then step away the required distance to discuss the work that is taking place and what can be expected that day. Please practice physical distancing with workers so everyone can remain safe. If you have questions, call the contact provided on this notice.</p>
	<p>Site Safety: Workers on site are responsible for the work assigned to them. If you have construction questions or an issue on site – ask to be directed to the site inspector. If the site inspector is unavailable, contact the person listed at the end of this notice.</p>
	<p>Accessible Accommodation: Residents who require accommodation (level entry, longer notice, etc.) must contact the Field Ambassador to arrange for access during the construction period.</p>
	<p>Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>
