1. 1636595 Ontario Ltd. (Report No. 7384)

o/a Fade A Way Jason Suzanna, President Applicant for the Renewal of Personal Services Settings Licence No. B56-4184424

DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Personal Services Settings Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Upon being renewed the Personal Services Settings Licence will be placed on probation for a period of Four (4) years. Jason Suzanna is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against 1636595 Ontario Ltd. and Jason Suzanna and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next Four (4) renewal(s) of the licence, Jason Suzanna must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against 1636595 Ontario Inc. and Jason Suzanna or any other concerns with respect to the conduct of the licensee, those matters and report no. 7384 and any updating material, may be brought back before the Tribunal for a full hearing."

2. 7540345 Canada Corp. (Report No. 7468)

o/a Greek & Co. Elena Arsenov, President Applicant for an Eating Establishment Licence (Application No. C022939)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on January 12, 2021, as follows:

"Eating Establishment Licence will be issued, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Upon being issued the Eating Establishment Licence will be placed on probation for a period of TWO (2) years. Elena Arsenov is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against 7540345 Canada Corp. and Elena Arsenov and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against 7540345 Canada Corp. and Elena Arsenov or any other concerns with respect to the conduct of the licensee, those matters and report no. 7468 and any updating material, may be brought back before the Tribunal for a full hearing."
