For Customers Cancelling (Opt –Out)

- City waste collection service is an all-or-nothing service. The decision to opt out of City waste collection means that your property is no longer eligible for City collection of any materials.
- Under the Solid Waste Management Fee structure, multi-residential properties receiving City collection service receive an annual tax rebate. The prorated rebate will reflect the discontinuation date of collection services. Billing adjustments will be reflected on the next utility bill from the City. Locations that do not receive City collection are not eligible for the rebate.
