1. Atiq Ahmed Nomani (Report No. 7420)

Applicant for the Renewal of Taxicab Owner's Licence No. V02-3101744, Plate No. A96

AND

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4703792

DECISION:

The Tribunal approved the joint Proposed Resolution signed on January 7, 2021, as follows:

"Taxicab Owner's Licence and Vehicle-For-Hire Driver's Licence will be renewed subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licences may be cancelled;
- (2) The Taxicab Owner's Licence and Vehicle-For-Hire Driver's Licence will be placed on probation for a period of Two (2) years. Atiq Ahmed Nomani is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Atiq Ahmed Nomani and conduct other investigations, as appropriate, to assess the Atiq Ahmed Nomani 's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws:
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Atiq Ahmed Nomani or any other concerns with respect to the conduct of the licensee, those matters and report no. 7420 and any updating material, may be brought back before the Tribunal for a full hearing."

2. Stephen Owolabi Agbeye (Report No. 7320)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4179537

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on January 28, 2020, as follows:

"Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) year(s). Mr. Agbeye is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Agbeye and conduct other investigations, as appropriate, to assess Mr. Agbeye's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Agbeye or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7320 and any updating material, may be brought back before the Tribunal for a full hearing."
